THE SURREY COUNTY COUNCIL in exercise of their powers under Sections 1(1) AND 2(1) to (3) and 4(2) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

Citation and commencement

1 THIS Order may be cited as "The Surrey County Council ((Various Roads in Tandridge) (Revocation and Consolidation of Waiting Loading and Unloading Prohibitions and Restrictions) Order 2006) (Amendment No. 1) Order 2008" and shall come into operation on 10 November 2008

Interpretation

- 2 (1) In this Order the expression "the Order of 2006" means The Surrey County Council (Various Roads in Tandridge) (Revocation and Consolidation of Waiting Loading and Unloading Prohibitions and Restrictions) Order 2006
 - (2) In this Order the expression "enactment" means any enactment whether public general or local and includes any order bye-law rule regulation scheme or other instrument having effect by virtue of an enactment
 - (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment
 - (4) Unless the context otherwise requires any expression used in this Order which is also used in the Order of 2006 shall have the same meaning as in that Order

Amendment of the Order of 2006

3 WITHOUT prejudice to the validity of anything done or to any liability incurred in

respect of any act or omission before the coming into operation of this Order the Order of 2006 shall have effect as though:-

- (a) in paragraph (1) of Article 2 there were added the following expressions which shall have the meanings hereby respectively assigned to them -
 - " "credit card" has the same meaning as in paragraph (6) of Section 35A of the Act "debit card" has the same meaning as in paragraph (6) of Section 35A of the Act"
- (b) in Article 3 the third line thereof for the words "to wait" there were substituted the words "to wait and/or to wait for the purpose of delivering or collecting goods or loading on or unloading from any vehicle"
- (c) for Article 9 there was substituted the following Article -
 - "9 THE prohibitions and restrictions imposed by Article 3 of this Order shall not apply to a community bus a local bus or a local service taxi whilst waiting at an authorised crew relief point bus timing point bus stand bus turning point or bus termination point situated in or adjacent to -
 - (a) any length of Croydon Road Caterham and/or of Mount Pleasant Road Caterham
 - (b) that length of Westway Caterham which extends from a point on a line being the prolongation across Westway at right angles to the centre line of the carriageway from a point being the intersection of the prolongations of the northern kerb-line of Westway and the north-western kerb-line of Avenue Road eastwards to the prolongation onto and across Westway of the eastern property boundary line of the premises currently occupied by Caterham on the Hill Library Westway Caterham Surrey CR3 5TP
 - (c) any length of Gresham Road Oxted and/or of Station Road East Oxted
 - (c) any length of Westmore Green Tatsfield
 - (d) any length of Limpsfield Road (B269) Warlingham and Hamsey Green
 - (e) any length of Godstone Road Whyteleafe
 which is identified on the plans as being subject to any prohibition and/or restriction
 on the waiting loading and/or unloading by vehicles"
