Citation and commencement

1 THIS Order may be cited as "The Surrey County Council ((Various Roads in Tandridge) (Revocation and Consolidation of Waiting Loading and Unloading Prohibitions and Restrictions) Order 2006) (Amendment No. 2) Order 2010" and shall come into operation on 25 October 2010

Interpretation

- 2 (1) In this Order the expression "the Order of 2006" means The Surrey County Council (Various Roads in Tandridge) (Revocation and Consolidation of Waiting Loading and Unloading Prohibitions and Restrictions) Order 2006
