((VARIOUS ROADS IN TANDRIDGE) (CONSOLIDATION OF FREE ON-STREET PARKING PLACES) ORDER 2006) (AMENDMENT NO. 2) ORDER 2010

THE SURREY COUNTY COUNCIL in exercise of their powers under Sections 32 35 and 36 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

Citation and commencement

- 1 THIS Order may be cited as "The Surrey County Council ((Various Roads in Tandridge) (Consolidation of Free On-Street Parking Places) Order 2006) (Amendment No. 2) Order 2010" and shall come into operation on 25 October 2010
 Interpretation
- 2 (1) In this Order the expression "the Order of 2006" means The Surrey County Council (Various Roads in Tandridge) (Consolidation of Free On-Street Parking Places) Order 2006
 - (2) In this Order the expression "enactment" means any enactment whether public general or local and includes any order bye-law rule regulation scheme or other instrument having effect by virtue of an enactment
 - (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment
 - (4) Unless the context otherwise requires any expression used in this Order which is also used in the Order of 2006 shall have the same meaning as in that Order

Amendment of the Order of 2006

- 3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Order of 2006 shall have effect as though:-
- (a) in paragraph (1) of Article 9 for the words "Any person duly authorised by the

Council or the Chief Constable of the Surrey Police (hereinafter called the Chief Constable) may suspend the use of" there were substituted the words "Subject to the following persons or organisations being able to exercise the function described below in this Article by virtue of legislation, a civil enforcement officer or a police constable in uniform, a person acting under the instructions (whether general or specific) of the Chief Officer of Police, or a person duly authorised by the Council or the Tandridge District Council of The Council Offices Station Road East Oxted Surrey RH8 0BT may suspend the use of"

- (b) in paragraph (2) of Article 9 for the words "A police constable in uniform" there were substituted the words "Subject as set out in paragraph (1) of this Article a police constable in uniform or a civil enforcement officer"
- (c) in sub-paragraph (ii) of paragraph (4) of Article 9 after the words "or a police constable in uniform" there were added the words "or a civil enforcement officer acting in the exercise of lawful authority"
- (d) in sub-paragraph (a) of paragraph (1) of Article 12 after the words "a police constable in uniform or a civil enforcement officer" there were added the words "acting in accordance with lawful authority"
- (e) for Article 15 there was substituted the following Article -
 - "15 (1) When a vehicle is left in a parking place in contravention of any of the provisions contained in this Order a person authorised in that behalf by the Council or a police constable in uniform or a civil enforcement officer may remove the vehicle or arrange for it to be moved from that parking place
 - BUT PROVIDED THAT civil enforcement officers shall not exercise the powers in this Article other than in accordance with the 1986 Regulations
 - (2) Where it appears to the Tandridge District Council of The Council Offices Station Road East Oxted Surrey RH8 0BT or a police

constable in uniform that a vehicle left in a parking place has been abandoned a civil enforcement officer or a police constable in uniform may in such manner as they consider necessary for the purpose remove the vehicle or arrange for it to be moved from that parking place:

PROVIDED THAT where the said Tandridge District Council or a police constable in uniform propose to move such a vehicle which in the opinion of the said Tandridge District Council or a police constable in uniform is in such a condition that it ought to be destroyed then they shall not less than twenty-four hours before removing it cause to be affixed to the vehicle a notice stating that they propose to remove it for destruction at the end of that period"
