(2) In this Order the expression "enactment" means any enactment whether public general or local and includes any order bye-law rule regulation scheme or other instrument having effect by virtue of an enactment

(3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment

(4) Unless the context otherwise requires any expression used in this Order which is also used in the Order of 2008 shall have the same meaning as in that Order

#### Amendment of the Order of 2008

3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Order of 2008 shall have effect as though:-

- (a) in paragraph (2) of Article 9 for the words "PROVIDED THAT in this paragraph "specified proportion" means such proportion applicable to all cases as may be determined by the Local Authorities acting through the Joint Committee" there were substituted the words "PROVIDED THAT in this paragraph "specified proportion" means such proportion applicable to all cases as may be determined by the Council"
