- 1        THIS Order may be cited as "The Surrey County Council Hillbury Road (B270) Whyteleafe (Residents Parking Place) Order 2011 (Amendment No. 3) Order 2019" and shall come into operation on 28 October 2019\_\_\_\_\_
- 2        (1)     In this Order "the Principal Order" means The Surrey County Council Hillbury Road (B270) Whyteleafe (Residents Parking Place) Order 2011\_\_\_\_\_
- (2)     In this Order the expression "enactment" means any enactment whether public general or local and includes any order bylaw rule regulation scheme or other instrument having effect by virtue of an enactment\_\_\_\_\_
- (3)     Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment\_\_\_\_\_
- (4)     Unless the context otherwise requires any expression used in this Order which is also used in the Principal Order shall have the same meaning as in that Order\_\_\_\_\_
- 3        WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Principal Order shall have effect as though:-
  - (a)     the phrase "or a motor cycle" was inserted in paragraph (1)(a) of Article 17 immediately following the words "or a goods vehicle"\_\_\_\_\_
  - (b)     the phrase "or a motor cycle" was inserted in paragraph (1)(b) of Article 17 immediately following the words "or goods vehicles"\_\_\_\_\_
  - (c)     the phrase "or a motor cycle" was inserted in paragraph (1)(c) of Article 17
