

**The Surrey County Council
(Various Roads in Tandridge) (Consolidation of Free Street Parking Places and
Revocation) Order 2006 (Amendment No.10) Order 2020**

Surrey County Council in exercise of their powers under Sections 32 35 36 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (hereinafter called "The Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to The Act hereby make the following Order:-

Citation and commencement

- 1 THIS Order may be cited as " The Surrey County Council (Various Roads in Tandridge) (Consolidation of Free Street Parking Places and Revocation) Order 2006 (Amendment No.10) Order 2020" and shall come into operation on 30 November 2020

Interpretation

- 2 (1) In this Order unless the context otherwise requires the following expressions shall have the same meanings hereby respectively assigned to them –

“enactment” means any enactment whether public general or local and includes any order bylaw rule regulation scheme or other instrument having effect by virtue of an enactment

“Principal Order” means The Surrey County Council (Various Roads in Tandridge) (Consolidation of Free Street Parking Places and Revocation) Order 2006

- (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment
- (3) Any reference in this Order to a numbered Article shall unless the context otherwise requires be construed as a reference to the Article bearing that number in this Order
- (4) Unless the context otherwise requires any expression used in this Order which is also used in the Principal Order shall have the same meaning as in that Principal Order

Amendment of the Principal Order

- 3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Principal Order shall have effect as though –
- (a) for the Schedule to the Principal Order there was substituted the Schedule set out in the Schedule to this Order
 - (b) in Article 2(1) of there was added the following expressions –
 - ““free parking ticket” means a ticket issued free of charge by a ticket machine indicating vehicle registration number of the vehicle, the date and time on which the ticket is valid and the date and time that the ticket expires obtained in accordance with Article 5A(a) of this Order and for use in such a parking place as specified in Article 3(b) of this Order”
 - ““parking ticket” has the same meaning as a “free parking ticket”
 - ““ticket machine” for the purpose of this Order means an apparatus designed to issue free parking tickets”

(c) in Part II of the Arrangement of Articles there was substituted the following –

(d) in Article 3 there was substituted the following similarly numbered

Article –

“Authorisation of such parking places

3 EACH part of a highway comprising the length of carriageway of a road identified on the plans and unless otherwise identified on the plans bounded on one side of that length by the edge of the carriageway and having a width throughout which varies between a minimum of 1.8 metres and a maximum of 9.1 metres is authorised to be used subject to the following provisions of this Order as –

(a) a parking place for use free of charge on such days and during such hours as specified in the key relating to the plans or

(b) a parking place for use free of charge subject to conditions as specified in Article 5A on such days during such hours as specified and identified as such a parking place in the key relating to the plans”

(e) in Article 5 there was substituted the following similarly numbered Article –

“Period for which a vehicle may be left in a parking place

5 WITHOUT prejudice to the provisions of Article 12 no person shall cause any vehicle to be left during the permitted hours in a parking place identified as such on the plans for longer than the maximum period permitted for waiting specified in relation to that parking place and as specified in the key relating to the plans – PROVIDED THAT nothing in this Article shall apply to:

(a) a disabled person’s vehicle which displays in the relevant position or in the prescribed manner a disabled person’s badge issued by any local authority

(b) such vehicles as display in a prominent position behind the windscreen so that it is facing forwards and can be entirely and easily seen from the front of the vehicle a valid waiver certificate issued by a person duly authorised by the Council to wait in accordance with the terms and conditions prescribed by the said certificate

PROVIDED THAT a waiver certificate may be cancelled at any time at the sole discretion of the Council and shall thereupon immediately cease to be valid and that a notification of such cancellation shall be sent by post to the holder of the certificate at any address which the Council believes to be that person's address and the certificate shall forthwith be surrendered to the Council"

(f) immediately following Article 5 there was inserted the following

Article –

"Parking tickets to be displayed on vehicles left in parking place subject to validation of the parking at the ticket machine

5A AT all times during which a vehicle is left in such a parking place during the permitted hours in the roads and lengths of roads specified in Article 3(b) the driver thereof before leaving the vehicle shall –

(a) enter their Vehicle Registration Number at the nearest ticket machine and obtain a free parking ticket and

(b) either –

(i) cause to be displayed in the case of a vehicle fitted with a front windscreen a valid parking ticket so that the side containing the date and time of expiry is directed outwards from immediately behind the windscreen or the window nearest to the edge of the carriageway and to be clearly visible to a person outside the vehicle or

- (ii) cause to be displayed in the case of a vehicle not fitted with a front windscreen a valid parking ticket so that the side containing the date and time of expiry is exhibited in a conspicuous position on the front or nearside of the vehicle

WITHOUT PREJUDICE to the provisions in this Article, if at any time while a vehicle is left in a parking places referred to in Article 3(b) and no indication appears in the vehicle's windscreen that the vehicle was validated or an indication that the parking period for which that vehicle was validated has expired then it shall be presumed unless contrary is provided that either –

- (i) the parking has not been validated in respect of that vehicle or
- (ii) the parking period for which that vehicle was validated has already expired

PROVIDED THAT nothing in this Article shall apply to a disabled person's vehicle which displays in the relevant position or in the prescribed manner a disabled person's badge issued by any local authority or to such vehicles as display in a prominent position behind the windscreen so that it is facing forwards and can be entirely and easily seen from the front of the vehicle a valid waiver certificate issued by a person duly authorised by the

Council to wait in accordance with the terms and conditions prescribed by the said certificate”

(g) immediately following Article 5A there was inserted the following

Article –

“No parking tickets to be displayed other than those obtained by validating the parking at the ticket machine

5B NO person shall display on a vehicle left in a parking place referred to in Article 3(b) during the permitted hours any ticket issued by a ticket machine situated near to that parking place other than the ticket issued by such a ticket machine upon validating the parking in respect of that vehicle in accordance with the provisions of Article 5A”

(h) immediately following Article 5B there was inserted the following

Article –

“Indications by ticket machine and parking tickets as evidence

5C (1) if at any time while the vehicle is left in a parking place in Article 3(b) during the permitted hours no free parking ticket issued by a ticket machine situated near to that parking place is displayed on the vehicle it shall be presumed unless the contrary is proved that the parking has not been validated

(2) if at any time while a vehicle is left in a parking place referred to in Article 3(b) during the permitted hours the free parking ticket issued by a ticket machine situated near to that parking place and displayed on the vehicle in

accordance with the provisions of Article 5A the free parking ticket issued by that ticket machine gives the indication that the period for which the parking was validated has expired and shall be presumed unless the contrary is proved that the parking has been validated and that the period of validity has already expired

- (3) any free parking ticket issued by a ticket machine situated near to that parking place shall be presumed unless the contrary is proved to have been issued on the day and at the time shown thereon

- (i) immediately following Article 5C there was inserted the following Article –

“Exemptions from validating parking at the ticket machine

5D WITHOUT PREJUDICE to Article 5 and Article 6 in the case of such a parking place as specified in Article 3(b) if on the leaving of a vehicle during the permitted hours in a parking bay (if such a parking bay is provided) in that parking place there is on every ticket machine situated in or in the vicinity of that parking place a notice placed by a civil enforcement officer or any person duly authorised by the Council or the District Council indicating that the ticket machine is out of order that vehicle shall be exempt from validating the parking in accordance with provisions specified in Article 5A”

- (j) immediately following paragraph (c) of Article 18 there was inserted the following paragraph –

“(d) install and maintain in proper working order at least one ticket machine in or in the vicinity of each such parking place referred to in Article 3(b)
