

**The Surrey County Council
(Various Roads in Tandridge) (Consolidation of Free Street Parking Places and
Revocation) Order 2006 (Amendment No.11) Order 2021**

Surrey County Council in exercise of their powers under Sections 32 35 36 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (hereinafter called "The Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to The Act hereby make the following Order:-

Citation and commencement

- 1 THIS Order may be cited as " The Surrey County Council (Various Roads in Tandridge) (Consolidation of Free Street Parking Places and Revocation) Order 2006 (Amendment No.11) Order 2021" and shall come into operation on 21 May 2021

Interpretation

- 2 (1) In this Order unless the context otherwise requires the following expressions shall have the same meanings hereby respectively assigned to them –

“enactment” means any enactment whether public general or local and includes any order bylaw rule regulation scheme or other instrument having effect by virtue of an enactment

“Principal Order” means The Surrey County Council (Various Roads in Tandridge) (Consolidation of Free Street Parking Places and Revocation) Order 2006

- (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment
- (3) Any reference in this Order to a numbered Article shall unless the context otherwise requires be construed as a reference to the Article bearing that number in this Order
- (4) Unless the context otherwise requires any expression used in this Order which is also used in the Principal Order shall have the same meaning as in that Principal Order

Amendment of the Principal Order

- 3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Principal Order shall have effect as though for the Schedule to the Principal Order there was substituted the Schedule set out in the Schedule to this Order
