((VARIOUS ROADS IN WAVERLEY) (CONSOLIDATION OF FREE STREET PARKING PLACES) (DISABLED PERSONS) (NO. 1) ORDER 2007) (AMENDMENT NO. 5) ORDER 2012

THE SURREY COUNTY COUNCIL in exercise of their powers under Sections 32 35 and 36 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

Citation and commencement

1 THIS Order may be cited as "The Surrey County Council ((Various Roads in Waverley) (Consolidation of Free Street Parking Places) (Disabled Persons) (No. 1) Order 2007) (Amendment No. 5) Order 2012" and shall come into operation on 10 December 2012

Interpretation

- 2 (1) In this Order the expression "the Order of 2007" means The Surrey County Council (Various Roads in Waverley) (Consolidation of Free Street Parking Places) (Disabled Persons) (No. 1) Order 2007
 - (2) In this Order the expression "enactment" means any enactment whether public general or local and includes any order bye-law rule regulation scheme or other instrument having effect by virtue of an enactment
 - (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment
 - (4) Unless the context otherwise requires any expression used in this Order which is also used in the Order of 2007 shall have the same meaning as in that Order

Amendment of the Order of 2007

3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Order of

2007 shall have effect as though -

- (a) in paragraph (1) of Article 9 for the words "or the Waverley Borough Council of The Council Offices The Burys Godalming Surrey GU7 1HR" there were substituted the words "or the Guildford Borough Council of the Council Offices Millmead House Millmead Guildford Surrey GU2 4BB"
- (b) for Article 15 there was substituted the following Article -
 - "15 (1) When a vehicle is left in a disabled persons' parking place in contravention of any of the provisions contained in this Order a person authorised in that behalf by the Council or a police constable in uniform or a civil enforcement officer may remove the vehicle or arrange for it to be moved from that parking place

 BUT PROVIDED THAT civil enforcement officers shall not exercise the powers in this Article other than in accordance with the 1986 Regulations
 - Offices Millmead House Millmead Guildford Surrey GU2 4BB or a police constable in uniform that a vehicle left in a disabled persons' parking place has been abandoned a civil enforcement officer or a police constable in uniform may in such manner as they consider necessary for the purpose remove the vehicle or arrange for it to be moved from that parking place:

PROVIDED THAT where the said Guildford Borough Council or a police constable in uniform propose to move such a vehicle which in the opinion of the said Guildford Borough Council or a police constable in uniform is in such a condition that it ought to be destroyed then they shall not less than twenty-four hours before removing it cause to be affixed to the vehicle a notice stating that they propose to remove it for destruction at the end of that period"

(c) for paragraph (1) of Article 26 there was substituted the following paragraph -

C

- "(1) The owner of a vehicle in respect of which the penalty charge has been incurred shall pay the penalty charge to the Council EITHER by cheque or postal order which shall be delivered or sent by post so as to reach the Parking Services Offices of Guildford Borough Council situate at the Bedford Road Multi-storey Car Park (Level 2) Laundry Road Guildford Surrey GU1 4PX within twenty-eight days of the issue of the penalty charge OR in cash in person at either the said Guildford Borough Council Offices not later than as aforesaid OR by credit card or debit card"
- in the Second Schedule to that Order in the first second third fourth fifth and sixth columns thereto headed respectively "Drawing Nos." "Date Drawn" "Rev'n" "Date Revised" "Rev'n" and "Date Revised" for the letters and numbers "3282/WAV/24085" "03/07" "A" "01/08" "B" and "06/10" specified respectively in each of those columns there were added under the seventh and eighth columns headed respectively "Rev'n" and "Date Revised" the letter and numbers "C" and "09/11" respectively
- (e) for the Second Schedule to that Order there was substituted the Second Schedule set out in The Schedule to this Order
