# (FARNHAM TOWN CENTRE CONTROLLED PARKING ZONE) (CONSOLIDATION OF WAITING LOADING AND UNLOADING PROHIBITIONS AND RESTRICTIONS AND ON-STREET PARKING PLACES) ORDER 2007) (AMENDMENT NO. 2) ORDER 2010

THE SURREY COUNTY COUNCIL in exercise of their powers under Sections 1(1) and 2(1) to 3 and 4 and 32 35 36 45 46 49 51 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

## Citation and commencement

1 THIS Order may be cited as "The Surrey County Council (Farnham Town Centre Controlled Parking Zone) (Consolidation of Waiting Loading and Unloading Prohibitions and Restrictions and On-Street Parking Places) Order 2007) (Amendment No. 2) Order 2010" and shall come into operation on 1 May 2010

# Interpretation

- 2 (1) In this Order the expression "the Order of 2007" means The Surrey County Council Farnham Town Centre Controlled Parking Zone (Consolidation of Waiting Loading and Unloading Prohibitions and Restrictions and On-Street Parking Places) Order 2007
  - (2) In this Order the expression "enactment" means any enactment whether public general or local and includes any order bye-law rule regulation scheme or other instrument having effect by virtue of an enactment
  - (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment
  - (4) Unless the context otherwise requires any expression used in this Order which is also used in the Order of 2007 shall have the same meaning as in that Order

### Amendment of the Order of 2007

- 3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Order of 2007 shall have effect as though -
- (a) in relation to the following expression in paragraph (1) of Article 2 there was substituted the following meaning in replacement for the meaning currently assigned to it -
  - " "parking permit" means a resident's parking permit inter alia bearing only the letter A in accordance with the provisions of Article 52 and issued by the Council pursuant to the provisions of Article 49"
- (b) in paragraph (1) of Article 2 there was added the following expression which shall have the meaning hereby respectively assigned to it -
  - " "Borough Council" means the Waverley Borough Council of The Council Offices
    The Burys Godalming Surrey GU7 1HR"
- (c) for the preamble to that Order there was substituted the following preamble "THE SURREY COUNTY COUNCIL in exercise of their powers under Sections
  1(1) 2(1) to (3) and 4 32 35 36 45 46 49 51 and 53 of and Part IV of Schedule
  9 to the Road Traffic Regulation Act 1984 (hereinafter called "The Act") and of all
  other enabling powers and after consultation with the Chief Officer of Police in
  accordance with Part III of Schedule 9 to The Act hereby make the following
  Order:-"
- (d) in paragraph (1) of Articles 17 and 29 for the words "Any person duly authorised by the Council or the Chief Constable of the Surrey Police (hereinafter called the "Chief Constable") may suspend the use of there were substituted the words "Subject to the following persons or organisations being able to exercise the function described below in this Article by virtue of legislation, a civil enforcement officer or a police constable in uniform, a person acting under the instructions (whether general or specific) of the Chief Officer of Police, or a person duly authorised by the Council or the Borough Council may suspend the use of"

- (e) in sub-paragraph (i) of paragraph (1) of Articles 20 and 32 for the words "Waverley Borough Council" there were substituted the words "Borough Council"
- (f) in Article 24 after the words for the leaving during the permitted hours of such vehicles only as are coaches there were added the words PROVIDED THAT nothing in this Article shall apply to a disabled person's vehicle which displays in the relevant position or in the prescribed manner a disabled person's badge issued by any local authority
- (g) in paragraph (1) of Article 39 for the words "Any person duly authorised by the Council or the Chief Constable may suspend the use of" there were substituted the words "Subject to the following persons or organisations being able to exercise the function described below in this Article by virtue of legislation, a civil enforcement officer or a police constable in uniform, a person acting under the instructions (whether general or specific) of the Chief Officer of Police, or a person duly authorised by the Council or the Borough Council may suspend the use of"
- (h) in paragraph (2) of Articles 17 29 and 39 for the words "A police constable in uniform" there were substituted the words "Subject as set out in paragraph (1) of this Article a police constable in uniform or a civil enforcement officer"
- (i) in sub-paragraph (a) of paragraph (1) of Articles 20 32 and 42 after the words "a police constable in uniform or a civil enforcement officer" there were added the words "acting in accordance with lawful authority"
- (j) in sub-paragraph (ii) of paragraph (4) of Articles 17 29 and 39 after the words "or a police constable in uniform" there were added the words "or a civil enforcement officer acting in the exercise of lawful authority"
- (k) in paragraph (5) of Article 49 for the words "Waverley Borough Council of The Council Offices The Burys Godalming Surrey GU7 1HR" there were substituted the words "the Borough Council"

- (I) in Article 62 in the first and second lines thereof for the words "Article 59 Article 60 Article 61 and Article 37" there were substituted the words "Article 59 Article 60 and Article 61"
- (m) in The Second Schedule to that Order in the first second third and fourth columns thereto headed respectively "Drawing Nos.
