# ((VARIOUS ROADS IN WAVERLEY) (CONSOLIDATION OF FREE STREET PARKING PLACES) (DISABLED PERSONS) (NO. 1) ORDER 2007) (AMENDMENT NO. 2) ORDER 2010

THE SURREY COUNTY COUNCIL in exercise of their powers under Sections 32 35 and 36 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

### Citation and commencement

- 1 THIS Order may be cited as "The Surrey County Council ((Various Roads in Waverley) (Consolidation of Free Street Parking Places) (Disabled Persons) (No. 1) Order 2007) (Amendment No. 2) Order 2010" and shall come into operation on 1 May 2010 Interpretation
- 2 (1) In this Order the expression "the Order of 2007" means The Surrey County Council (Various Roads in Waverley) (Consolidation of Free Street Parking Places) (Disabled Persons) (No. 1) Order 2007
  - (2) In this Order the expression "enactment" means any enactment whether public general or local and includes any order bye-law rule regulation scheme or other instrument having effect by virtue of an enactment
  - (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment
  - (4) Unless the context otherwise requires any expression used in this Order which is also used in the Order of 2007 shall have the same meaning as in that Order

## Amendment of the Order of 2007

3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Order of 2007 shall have effect as though -

- in paragraph (1) of Article 9 for the words "Any person duly authorised by the Council or the Chief Constable of the Surrey Police (hereinafter called the Chief Constable) may suspend the use of there were substituted the words "Subject to the following persons or organisations being able to exercise the function described below in this Article by virtue of legislation, a civil enforcement officer or a police constable in uniform, a person acting under the instructions (whether general or specific) of the Chief Officer of Police, or a person duly authorised by the Council or the Waverley Borough Council of The Council Offices The Burys Godalming Surrey GU7 1HR may suspend the use of"
- (b) in paragraph (2) of Article 9 for the words "A police constable in uniform" there were substituted the words "Subject as set out in paragraph (1) of this Article a police constable in uniform or a civil enforcement officer"
- (c) in sub-paragraph (ii) of paragraph (4) of Article 9 after the words "or a police constable in uniform" there were added the words "or a civil enforcement officer acting in the exercise of lawful authority"
- (d) in sub-paragraph (a) of paragraph (1) of Article 12 after the words "a police constable in uniform or a civil enforcement officer" wherever those words occur there were added the words "acting in accordance with lawful authority"
- (e) in the Second Schedule to that Order in the first second third and fourth columns thereto headed respectively "Drawing Nos." "Date Drawn" "Rev'n" and "Date Revised" and for the letters and numbers "3282/WAV/24076" "03/07" "A" and "01/08" specified respectively in each of those columns there were added under the fifth and sixth columns headed respectively "Rev'n" and "Date Revised" the letters and numbers "B" and "10/09" respectively
- (f) in the Second Schedule to that Order in the first second third and fourth columns thereto headed respectively "Drawing Nos." "Date Drawn" "Revin" and "Date Revised" and for the letters and numbers "3282/WAV/24078" "03/07" "A" and

- "01/08" specified respectively in each of those columns there were added under the fifth and sixth columns headed respectively "Rev'n" and "Date Revised" the letters and numbers "B" and "10/09" respectively
