SURREY COUNTY COUNCIL in exercise of their powers under Sections 1(1) 2(1) to (3) 4(2) 32 35 36 45 and 46 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order: -

### Citation and Commencement

 THIS Order may be cited as "The Surrey County Council (West Byfleet Controlled Parking Zone in the Borough of Woking (Consolidation of Waiting Loading and Unloading Restrictions and On-Street Parking Places) Order 2005) (Amendment No. 1) Order 2006" and shall come into operation on 1 April 2006

### Interpretation

 (1) In this Order "the Principal Order" means The Surrey County Council West Byfleet Controlled Parking Zone in the Borough of Woking (Consolidation of Waiting Loading and Unloading Restrictions and On-Street Parking Places) Order 2005

(2) In this Order the expression "enactment" means any enactment whether public general or local and includes any order bylaw rule regulation scheme or other instrument having effect by virtue of an enactment

(3) Any reference in this Order to an enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment

(4) Unless the context otherwise requires any expression used in this Order which is also used in the Principal Order shall have the same meaning as in that Order

### Amendment of the Principal Order

 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Principal Order shall have effect as though: -

- (a) In paragraph (1) of Article 2 in the definition of "protective cover" the Article numbers "21(3) 22(3) 25(2) and 27(2)" were omitted and substituted by the Article numbers "60(4) 61(3)(b) and 64(e)"
- (b) In paragraph (1) of Article 2 the words "telecommunications system" and the meaning assigned thereto were deleted it their entirety
- (c) In paragraph (1) of Article 2 the following definition be inserted immediately after the definition of "driver"

""electronic communications apparatus" has the same meaning as in paragraph 1 of Schedule 2 to the Telecommunications Act 1984"

- (d) In sub-paragraph (iv) of paragraph (b) of Article 4 the words"telecommunication system" were omitted and substituted by the words"electronic communications apparatus"
- (e) In sub-paragraph (b) of paragraph (1) of Article 15 the words
  "telecommunication system" were omitted and substituted by the words
  "electronic communications apparatus"
- (f) In sub-paragraph (b) of paragraph (1) of Article 25 the words"telecommunication system" were omitted and substituted by the words"electronic communications apparatus"
- (g) In paragraph (b) of Article 35 the words "telecommunication system" were omitted and substituted by the words "electronic communications apparatus"
- (h) In sub-paragraph (b)(iii) of paragraph (1) of Article 50 the words
  "telecommunication system" were omitted and substituted by the words
  "electronic communications apparatus"
- (i) In the Second Schedule to the Principal Order for the plan numbered 3282/WOK/20000 there were substituted the plan numbered 3282/WOK/20000A annexed to this Order
- (j) In the Second Schedule to the Principal Order in columns headed "Drawing No" and "Date Drawn" the letters and numbers 3282/WOK/20000 and 06/05 respectively there be added under the columns headed "Rev'n" and "Date Revised" the letters and numbers "A" and "02/06" respectively
- (k) For the Second Schedule to the Principal Order there was substituted the Second Schedule set out in the Schedule to this Order
