Citation and commencement

 THIS Order may be cited as "The Surrey County Council ((Various Roads in Woking) (Consolidation of Free Street Parking Places) (Disabled Persons) Order 2005) (Amendment No.2) Order 2006" and shall come into operation on 18 December 2006

Interpretation

- (1) In this Order "the Principal Order" means The Surrey County Council (Various Roads in Woking) (Consolidation of Free Street Parking Places)
 (Disabled Persons) Order 2005
 - (2) In this Order the expression "enactment" means any enactment whether public general or local and includes any order bylaw rule regulation scheme or other instrument having effect by virtue of an enactment
 - (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment
 - (4) Unless the context otherwise requires any expression used in this Order which is also used in the Principal Order shall have the same meaning as in that Order

Amendment to the Principal Order

3. WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Principal Order shall have effect as though: -

- (a) In the Second Schedule to the Principal Order for the plan numbered 3282/WOK/20015 there were substituted the plan numbered 3282/WOK/20015A annexed to this Order
- (b) In the Second Schedule to the Principal Order there be added sequentially the plan numbered 3282/WOK/20102 annexed to this Order
- (c) In the Second Schedule to the Principal Order in the columns headed "Drawing No" and "Date Drawn" the letters and numbers 3282/WOK/20015 and 06/05 respectively there were added under the columns headed "Rev'n" and "Date Revised" the letters and numbers "A" and "12/06" respectively
- (d) In the Second Schedule to the Principal Order there be added an additional row immediately following that representing plan number 3282/WOK/20101 such row in the columns headed "Drawing Number" and "date drawn" respectively there were added the letters and numbers "3282/WOK/20102" and "12/06" respectively
