SURREY COUNTY COUNCIL in exercise of their powers under Sections 1(1) and 2(1) to (3) and 4 and 32 35 36 45 46 49 51 and 53 of and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

Citation and commencement

1 THIS Order may be cited as "The Surrey County Council (Brookwood Controlled Parking Zone)(Consolidation of Waiting Restrictions and On-Street Parking Places) Order 2005) (Amendment No.7) Order 2011" and shall come into operation on 1 December 2011\_\_\_\_\_

Interpretation

- 2 (1) In this Order "the Principal Order" means The Surrey County Council (Brookwood Controlled Parking Zone)(Consolidation of Waiting Restrictions and On-Street Parking Places) Order 2005\_\_\_\_\_
- (2) In this Order the expression "enactment" means any enactment whether public general or local and includes any order bylaw rule regulation scheme or other instrument having effect by virtue of an enactment\_\_\_\_\_
- (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment\_\_\_\_\_
- (4) Unless the context otherwise requires any expression used in this Order which is also used in the Principal Order shall have the same meaning as in that Order\_\_\_\_\_

Amendment of The Principal Order

3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Principal Order shall have effect as though:-

- (a) There was added as Article 22A the following Article –

**“Application for the Re-Issue of a Residents Parking Permit upon a change of vehicle with a different registration mark**

22A WHERE a resident or a parking permit holder applies for the issue of a further parking permit due to that resident or that parking permit holder changing the vehicle in respect of which the original parking permit was issued so that the original parking permit no longer bears the registration mark of the vehicle in respect of which that original parking permit was issued under the provisions of Article 22(1) then the original parking permit shall be surrendered to the Council and immediately a further parking permit will be issued bearing the registration mark of the new vehicle PROVIDED THAT there shall then be payable to the Council a sum of fifteen pounds for the issue of that further parking permit which shall be valid for the remainder of the period stated on the original parking permit under the provisions of Article 26(b)”

- (b) In Article 2 the following expression and meaning assigned to it was added –  
“registration mark” has the same meaning as in Section 31 of the Vehicles (Crime) Act 2001”
- (c) In Article 24 (2) for the words “paragraph (3) (a) (b) (d) (e) or (f)” there were substituted the words “paragraph (3) (a) (d) (e) or (f)”
- (d) Article 26 (b) was deleted in its entirety
- (e) For the Second Schedule to the Principal Order there was substituted the Second Schedule set out in THE SCHEDULE to this Order\_\_\_\_\_
