SURREY COUNTY COUNCIL in exercise of their powers under Sections 1(1) and 2 (1) to (3) 4(2) 32 35 36 45 46 49 51 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order: -

Citation and commencement

1 THIS Order may be cited as "The Surrey County Council (Various Roads in Woking) (Amendment of Waiting Loading and Unloading Prohibition and On-Street Parking Places Orders) (Amendment No.14) Order 2017" and shall come into operation on 21 July 2017\_\_\_\_\_

Interpretation

- 2 (1) In this Order the expression "enactment" means any enactment whether public general or local and includes any order bylaw rule regulation scheme or other instrument having effect by virtue of an enactment\_\_\_\_\_
- (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment\_\_\_\_\_
- (3) Unless the context otherwise requires any expression used in this Order which is also used in the amended Order shall have the same meaning as in that Order\_\_\_\_\_

Amendment of the Principal Orders

3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order: -

(a) The Surrey County Council Woking Controlled Parking Zone (Consolidation of Waiting Loading and Unloading Restrictions and On-Street Parking Places) Order 2005 shall have effect as though –

(i) In Article 2 there was added the following item: -

"Woking Town Centre Restricted Zone" means the roads or lengths of roads bounded by a blue broken line and labelled "Woking Town Centre Restricted Zone" on the plans other than such lengths of road authorised or designated as a parking place or a loading bay or a taxi rank "

(ii) In line 7 of Article 3 after the word “plans” there was added the following words: -  
“and/or to wait and/or wait for the purpose of delivering or collecting goods or loading  
on or unloading from any vehicle at any time in any of the roads or lengths of roads  
situate within the Woking Town Centre Restricted Zone”\_\_\_\_\_

(ii) for the List of Plans in Second Schedule to the said Order there was substituted the List of  
Plans set out in the Schedule to this Order\_\_\_\_\_

(b) The Surrey County Council Brookwood Controlled Parking Zone in the Borough of Woking  
(Consolidation of Waiting Restrictions and On-Street Parking Places) Order 2005 shall have  
effect as though for the List of Plans in Second Schedule to the said Order there was  
substituted the List of Plans set out in the Schedule to this Order\_\_\_\_\_

(c) The Surrey County Council West Byfleet Controlled Parking Zone in the Borough of  
Woking (Consolidation of Waiting Loading and Unloading Restrictions and On-Street Parking  
Places) Order 2005 shall have effect as though for the List of Plans in Second Schedule to the  
said Order there was substituted the List of Plans set out in the Schedule to this Order\_\_\_\_\_

(d) The Surrey County Council (Various Roads in Woking) (Consolidation of Free Street  
Parking Places) (Disabled Persons) Order 2005 shall have effect as though for the List of  
Plans in Second Schedule to the said Order there was substituted the List of Plans set out in  
the Schedule to this Order\_\_\_\_\_

(e) The Surrey County Council (Various Roads in Woking) (Consolidation of Free Street  
Parking Places and Revocation) Order 2005 shall have effect as though for the List of Plans in  
Schedule to the said Order there was substituted the List of Plans set out in the Schedule to  
this Order\_\_\_\_\_

(f) The Surrey County Council (Various Roads in Woking) (Prohibition of Stopping Outside  
Schools) (No.1) Order 2005 shall have effect as though for the List of Plans in Second  
Schedule to the said Order there was substituted the List of Plans set out in the Schedule to  
this Order\_\_\_\_\_

(g) The Surrey County Council (Various Roads in Woking) (Revocation and Consolidation of  
Waiting Loading and Unloading Prohibition and Restriction) Order 2005 shall have effect as  
though for the List of Plans in Second Schedule to the said Order there was substituted the  
List of Plans set out in the Schedule to this Order\_\_\_\_\_

(h) The Surrey County Council (Borough of Woking) (Solo Motor Cycle Parking Places) Order  
2014 shall have effect as though for the List of Plans in Schedule to the said Order there was

substituted the List of Plans set out in the Schedule to this Order\_\_\_\_\_

(i) The Surrey County Council (Borough of Woking) On-Street Bus Parking Places Order 2015 shall have effect as though for the List of Plans in Schedule to the said Order there was substituted the List of Plans set out in the Schedule to this Order\_\_\_\_\_

(j) The Surrey County Council Various Roads in the Borough of Woking (Permit Holders' Parking Places) Order 2015 shall have effect as though for the List of Plans in Second Schedule to the said Order there was substituted the List of Plans set out in the Schedule to this Order\_\_\_\_\_

(k) The Surrey County Council (Various Roads in the Borough of Woking) Permit Holders' On-Street Parking Places (Permit Zones) Order 2015 shall have effect as though for the List of Plans in Second Schedule to the said Order there was substituted the List of Plans set out in the Schedule to this Order\_\_\_\_\_

(l) The Surrey County Council (Borough of Woking) Police Vehicles' On-Street Parking Places Order 2015 shall have effect as though for the List of Plans in Schedule to the said Order there was substituted the List of Plans set out in the Schedule to this Order\_\_\_\_\_

(m) The Surrey County Council Goldsworth Road (A320) Woking (Loading Bays) Order 2016 shall have effect as though –

(i) In the title and in Article 1 for the expression “Goldsworth Road (A320)” there were substituted the words “Various Roads in”\_\_\_\_\_

(ii) In Article 3 the expression “of Goldsworth Road (A320) Woking” was omitted in its entirety
