SURREY COUNTY COUNCIL in exercise of their powers under Sections 1(1) 2(1) to (3) 4(2) 32 35 36 45 46 47 48 49 51 52 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order: -

Citation and commencement

1. THIS Order may be cited as "The Surrey County Council (Various Roads in Woking) (Amendment of Waiting Loading and Unloading Prohibition and On-Street Parking Places Orders) (Amendment No.17) Order 2019" and shall come into operation on 2 February 2019_

Interpretation

2. (1) In this Order the expression "enactment" means any enactment whether public general or local and includes any order bylaw rule regulation scheme or other instrument having effect by virtue of an enactment_____
- (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment_____
- (3) Unless the context otherwise requires any expression used in this Order which is also used in the amended Order shall have the same meaning as in that Order_____

Amendment of the Principal Orders

3. WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order: -

(a) The Surrey County Council Woking Controlled Parking Zone (Consolidation of Waiting Loading and Unloading Restrictions and On-Street Parking Places) Order 2005 shall have effect as though for the List of Plans in Second Schedule to the said Order there was substituted the List of Plans set out in the First Schedule to this Order_____

(b) The Surrey County Council Brookwood Controlled Parking Zone in the Borough of Woking (Consolidation of Waiting Restrictions and On-Street Parking Places) Order 2005 shall have

effect as though for the List of Plans in Second Schedule to the said Order there was substituted the List of Plans set out in the First Schedule to this Order_____

(c) The Surrey County Council West Byfleet Controlled Parking Zone in the Borough of Woking (Consolidation of Waiting Loading and Unloading Restrictions and On-Street Parking Places) Order 2005 shall have effect as though for the List of Plans in Second Schedule to the said Order there was substituted the List of Plans set out in the First Schedule to this Order____

(d) The Surrey County Council (Various Roads in Woking) (Consolidation of Free Street Parking Places) (Disabled Persons) Order 2005 shall have effect as though for the List of Plans in Second Schedule to the said Order there was substituted the List of Plans set out in the First Schedule to this Order_____

(e) The Surrey County Council (Various Roads in Woking) (Consolidation of Free Street Parking Places and Revocation) Order 2005 shall have effect as though for the List of Plans in Schedule to the said Order there was substituted the List of Plans set out in the First Schedule to this Order_____

(f) The Surrey County Council (Various Roads in Woking) (Prohibition of Stopping Outside Schools) (No.1) Order 2005 shall have effect as though for the List of Plans in Second Schedule to the said Order there was substituted the List of Plans set out in the First Schedule to this Order_____

(g) The Surrey County Council (Various Roads in Woking) Revocation and Consolidation of Waiting Loading and Unloading Prohibition and Restriction) Order 2005 shall have effect as though –

(1) For Article 3 to the said Order there was substituted the following similarly numbered Article –

“3 SAVE as provided in Articles 4 5 6 7 and 8 of this Order no person shall except upon the direction or with the permission of a police constable in uniform or a civil enforcement officer cause or permit any vehicle -

(i) to wait and/or to wait for the purpose of delivering or collecting goods or loading on or unloading from any vehicle at the times indicated on the plans in the roads and lengths of roads identified on the Plans excluding the areas marked by a black broken line and labelled as Woking Controlled Parking Zone, West Byfleet Controlled Parking Zone or Brookwood Controlled Parking Zone_____

(ii) and/or to wait at any time in any of the roads or lengths of roads on the plans situate within the area marked with a blue line broken by the letters “RZ”

indicated as a "Restricted Parking Zone" on the key to the plans at the times indicated by the said key"_____

(2) for the List of Plans in Second Schedule to the said Order there was substituted the List of Plans set out in the First Schedule to this Order_____

(h) The Surrey County Council (Borough of Woking) (Solo Motor Cycle Parking Places) Order 2014 shall have effect as though for the List of Plans in Schedule to the said Order there was substituted the List of Plans set out in the First Schedule to this Order_____

(i) The Surrey County Council (Borough of Woking) On-Street Bus Parking Places Order 2015 shall have effect as though for the List of Plans in Schedule to the said Order there was substituted the List of Plans set out in the First Schedule to this Order_____

(j) The Surrey County Council Various Roads in the Borough of Woking (Permit holders' parking places) Order 2015 shall have effect as though -

(1) The words "save that residents of the properties specified in Resident Area 9 in the table contained in the First Schedule to this Order shall be limited to two permits for each such place of abode" was added to sub-paragraph (b) of paragraph (1) of Article 17 immediately following the words "available to that place of abode"_____

(2) For the First Schedule to the said Order there was substituted the Second Schedule to this Order_____

(3) for the List of Plans in Second Schedule to the said Order there was substituted the List of Plans set out in the First Schedule to this Order_____

(k) The Surrey County Council (Various Roads in the Borough of Woking) Permit Holders' On-Street Parking Places (Permit Zones) Order 2015 shall have effect as though for the List of Plans in Second Schedule to the said Order there was substituted the List of Plans set out in the First Schedule to this Order_____

(l) The Surrey County Council (Borough of Woking) Police Vehicles' On-Street Parking Places Order 2015 shall have effect as though for the List of Plans in Schedule to the said Order there was substituted the List of Plans set out in the First Schedule to this Order_____

(m) The Surrey County Council Various Roads in Woking (Loading Bays) Order 2016 shall have effect as though for the List of Plans in Schedule to the said Order there was substituted the List of Plans set out in the First Schedule to this Order_____

(n) The Surrey County Council Various Roads in the Borough of Woking (On-Street Car Club Parking Places) Order 2017 shall have effect as though for the List of Plans in the Second

Schedule to the said Order there was substituted the List of Plans set out in the First
