

**The Surrey County Council
(Various Roads in Mole Valley)
(Amendment of Waiting Loading and Unloading Prohibition and On-Street
Parking Places Orders)(Amendment No.3) Order 2022**

Surrey County Council in exercise of their powers under Sections 1(1) and 2 (1) to (3) 4 32 35 36 45 46 49 51 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (hereinafter called "The Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to The Act hereby make the following Order:-

Citation and commencement

- 1 THIS Order may be cited as "The Surrey County Council (Various Roads in Mole Valley) (Amendment of Waiting Loading and Unloading Prohibition and On-Street Parking Places Orders) (Amendment No.3) Order 2022" and shall come into operation on 1 June 2022

Interpretation

- 2 (1) In this Order unless the context otherwise requires the following expressions shall have the same meanings hereby respectively assigned to them –

"enactment" means any enactment whether public general or local and includes any order bylaw rule regulation scheme or other instrument having effect by virtue of an enactment

"Principal Order" means each of the relevant Principal Orders listed in Article 3(a) Article 3(b) Article 3(c) Article 3(d) Article 3(e) Article 3(f) Article 3(g) Article 3(h) and Article 3(i)

- (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment
- (3) Any reference in this Order to a numbered Article shall unless the context otherwise requires be construed as a reference to the Article bearing that number in this Order
- (4) Unless the context otherwise requires any expression used in this Order which is also used in the Principal Order shall have the same meaning as in that Principal Order

Amendment of the Principal Orders

3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order:-
