

The Surrey County Council

(Amendment No. 7) Order 2023

SURREY COUNTY COUNCIL in exercise of their powers under Sections 1(1) 2(1) to (3) and 4(2) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order: -

Citation and commencement

1 THIS Order may be cited as "The Surrey County Council (Various Roads in Runnymede) (Revocation and Consolidation of Waiting Loading and Unloading Prohibition and Restriction) Order 2016 (Amendment No. 7) Order 2023" and shall come into operation on 25 March 2023_____

Interpretation

- 2 (1) In this Order "the Principal Order" means The Surrey County Council (Various Roads in Runnymede) (Revocation and Consolidation of Waiting Loading and Unloading Prohibition and Restriction) Order 2016_____
- (2) In this Order the expression "enactment" means any enactment whether public general or local and includes any order byelaw rule regulation scheme or other instrument having effect by virtue of an enactment_____
- (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment_
- (4) Unless the context otherwise requires any expression used in this Order which is also used in the Principal Order shall have the same meaning as in that Order_____

Amendment of the Principal Order

3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Principal Order shall have effect as though –

(1) In Article 3 after the word “plans” there was added the following words –

“and to wait and/or wait for the purpose of delivering or collecting goods or loading on or unloading from any vehicle at any time in any of the roads or lengths of roads situate within an area labelled as a Restricted Parking Zone in the aforesaid plans”

(2) for the First Schedule to the Principal Order there was substituted the First Schedule set out in the Schedule to this Order
