SURREY COUNTY COUNCIL in exercise of their powers under Sections 32 35 and 36 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:

1 THIS Order may be cited as "The Surrey County Council (Various Roads in Runnymede) (Consolidation of Free Street Parking Places) (Disabled Persons) Order 2016 (Amendment No. 2) Order 2018" and shall come into operation on 24 February 2018_____

- 2 (1) In this Order "the Principal Order" means The Surrey County Council (Various Roads in Runnymede) (Consolidation of Free Street Parking Places and Loading Bays and Revocation) Order 2016_____
- (2) In this Order the expression "enactment" means any enactment whether public general or local and includes any order byelaw rule regulation scheme or other instrument having effect by virtue of an enactment_____
- (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment
- (4) Unless the context otherwise requires any expression used in this Order which is also used in the Principal Order shall have the same meaning as in that Order_____

3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Principal Order shall have effect as though for the First Schedule to the Principal Order there was substituted the First Schedule set out in the Schedule to this Order_
