Citation and commencement

Interpretation

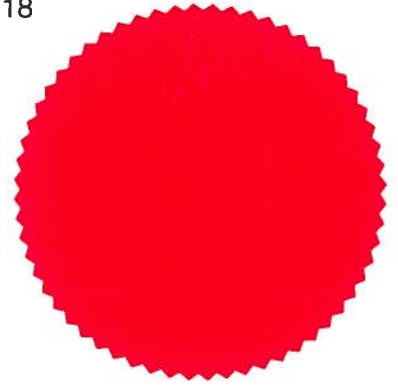
2. (1) In this Order "the Principal Order" means The Surrey County Council Council (Prospect Place (D3287) Staines-Upon-Thames in the Borough of Spelthorne) (Permit Holders' On-Street Parking Place) (Permit Zone) Order 2014
- (2) In this Order the expression "enactment" means any enactment whether public general or local and includes any order byelaw rule regulation scheme or other instrument having effect by virtue of an enactment
- (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment

Amendment of the Principal Order

3. WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Principal Order shall have effect as though for The Second Schedule to the Principal Order there was substituted the Second Schedule set out in the Schedule to this Order_____
