SURREY COUNTY COUNCIL in exercise of their powers under Sections 32 35 36 45 46 49 51 AND 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order: -

Citation and commencement

1 THIS Order may be cited as "The Surrey County Council ((Various Roads in Spelthorne) (Residents' On-Street Parking Places) Order 2010) (Amendment No.2) Order 2012" and shall come into operation on 28 May 2012

Interpretation

2. (1) In this Order "the Principal Order" means The Surrey County Council (Various Roads in Spelthorne) (Residents' On-Street Parking Places) Order 2010;
- (2) In this Order the expression "enactment" means any enactment whether public general or local and includes any order byelaw rule regulation scheme or other instrument having effect by virtue of an enactment
- (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment
- (4) Unless the context otherwise requires any expression used in this Order which is also used in the Principal Order shall have the same meaning as in that Order

Amendment of the Principal Order

3. WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Principal Order shall have effect as though: -

- (a) In paragraph (1) of Article 17 for the words "is as follows" there were substituted the following words: -

“shall be calculated as the sum of the number of vehicles registered to residents at that usual place of abode minus the total number of off-street parking spaces available to that usual place of abode”

- (b) Sub-paragraphs (i) and (ii) and (iii) of paragraph (1) of Article 17 were deleted in their entirety
- (c) In Paragraph (4) of Article 17 for the words “one or two residents parking permit(s)” there were substituted the words “one or more of Residents’ Parking Permits as may be issued in accordance with the provision contained in paragraph (1) of this Article”
- (d) In Paragraph (4) of Article 23 for the word “thirty” there was substituted the number “120”
- (e) For the First Schedule to the Principal Order there was substituted the First Schedule to this Order
- (f) In the Second Schedule for the plans numbered 3282/SPEL/0112D and 3282/SPEL/0113B and 3282/SPEL/0114C there was substituted the plans numbered 3282/SPEL/0112E and 3282/SPEL/0113C and 3282/SPEL/0114D respectively
- (g) For the Second Schedule to the Principal Order there was substituted the Second Schedule to this Order
