SURREY COUNTY COUNCIL in exercise of their powers under Sections 1(1) and 2 (1) to (3) and 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

Citation and commencement

1 THIS Order may be cited as "The Surrey County Council (Various Roads in Surrey Heath) (Revocation and Consolidation of Waiting Loading and Unloading Prohibition and Restriction) Order 2006 (Amendment No.1) Order 2007" and shall come into operation on 20 August 2007

Interpretation

2 (1) In this Order "the Principal Order" means "The Surrey County Council (Various Roads in Surrey Heath) (Revocation and Consolidation of Waiting Loading and Unloading Prohibition and Restriction) Order 2006"

(2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment\_\_\_\_\_

(3) Unless the context otherwise requires any expression used in this Order which is also used in the Principal Order shall have the same meaning as in that Order\_\_\_\_\_

Amendment of the Principal Order

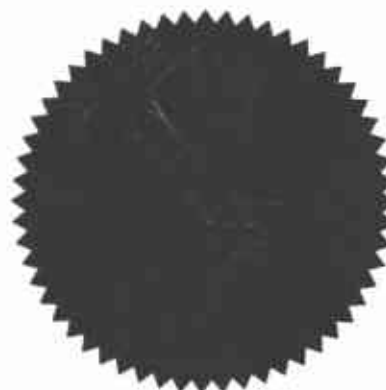
