**((VARIOUS ROADS IN SURREY HEATH) (FREE STREET PARKING PLACES)  
(DISABLED PERSONS) ORDER 2006) (AMENDMENT NO. 2) ORDER 2008**

THE SURREY COUNTY COUNCIL in exercise of their powers under Sections 32 35 and 36 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

**Citation and commencement**

1 THIS Order may be cited as "The Surrey County Council ((Various Roads in Surrey Heath) (Free Street Parking Places) (Disabled Persons) Order 2006) (Amendment No. 2) Order 2008" and shall come into operation on 23 June 2008

**Interpretation**

2 (1) In this Order "the Order of 2006" means The Surrey County Council (Various Roads in Surrey Heath) (Free Street Parking Places) (Disabled Persons) Order 2006

(2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment

(3) Unless the context otherwise requires any expression used in this Order which is also used in the Order of 2006 shall have the same meaning as in that Order

**Amendment of the Order of 2006**

3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Order of 2006 shall have effect as though:-

(a) in the title to that Order (wherever that title appears) for the words "Free Street Parking Places" there were substituted the words "Free On-Street Parking Places"

(b) in PART II of the ARRANGEMENT OF ARTICLES for the words "PART II - DESIGNATION OF DISABLED PERSONS FREE STREET PARKING PLACES"

there were substituted the words "PART II - PARTS OF ROADS AUTHORISED TO BE USED AS DISABLED PERSONS' FREE ON-STREET PARKING PLACES"

- (c) in PART II of the ARRANGEMENT OF ARTICLES for the words "Designation of parking places" and "Vehicles for which parking places are designated" there were substituted respectively the words "Authorisation of parking places" and "Vehicles for which parking places are authorised to be used"
- (d) in the preamble for the words "THE COUNTY COUNCIL OF SURREY" there were substituted the words "THE SURREY COUNTY COUNCIL"
- (e) in paragraph (1) of Article 2 for the expressions "parking place" "street parking place" and "permitted hours" and the meanings assigned thereto there was substituted respectively the following expressions and meanings assigned thereto -
  - " "parking place" means any part of a road authorised by this Order to be used as a street parking place
  - "permitted hours" means the hours specified in the key relating to the plans attached to this Order
  - "street parking place" has the same meaning as in Section 142 of the Act"
- (f) in paragraph (1) of Article 2 there were added the following expressions -
  - " "credit card" has the same meaning as in paragraph (6) of Section 35A of the Act
  - "debit card" has the same meaning as in paragraph (6) of Section 35A of the Act"
- (g) for the words "PART II - DESIGNATION OF FREE STREET PARKING PLACES" there were substituted the words "PART II – AUTHORISATION AND USE OF FREE ON-STREET PARKING PLACES"
- (h) for Article 3 there was substituted the following similarly numbered Article -
  - "Authorisation of parking places
  - 3 EACH part of a highway comprising the length of carriageway of a road identified by the key relating to the plans and on any of the plans as a parking place (excluding the areas shown marked by a black broken line and labelled as Camberley Controlled Parking Zone) and unless otherwise identified on the plans bounded on one side of that length by the edge of the carriageway and having a

width throughout of 2.7 metres is authorised to be used subject to the following provisions of this Order as a parking place for use free of charge by such vehicles specified in Article 4 on such days and during the hours as specified in the key relating to the plans"

- (i) in Article 4 in the shoulder heading thereto for the words "are designated" there were substituted the words "are authorised to be used"
- (j) in Article 4 the third line thereof the words "relevant position or in the" were omitted
- (k) in Article 5 the second line thereof for the words "a parking place described in the plans attached to this Order" there were substituted the words "a parking place identified on the plans"
- (l) in Article 5 the fifth line thereof for the words "than the hours specified on the plans" there were substituted the words "than the hours specified in the key relating to the plans"
- (m) in Article 6 the second line thereof for the words "from a parking place described in the plans attached to this Order" there were substituted the words "from a parking place identified on the plans"
- (n) in Article 6 the fourth and fifth lines thereof for the words "shall until the expiration of the hour(s) specified on the plans" there were substituted the words "shall until the expiration of the hours specified in the key relating to the plans"
- (o) in Article 7 and Article 13 for the words "disabled person's parking place" wherever those words occur there were substituted the words "parking place"
- (p) in sub-paragraph (b) of paragraph (1) of Article 9 the sixth line thereof for the words "telecommunication system" there were substituted the words "electronic communications apparatus"
- (q) in paragraph (1) of Article 26 the fourth and fifth lines thereof for the words "the Cash Office of the Car Parks Manager Surrey Heath House Knoll Road Camberley Surrey GU15 3HD" there were substituted the words "the Surrey Heath Borough Council situated at Surrey Heath House Knoll Road Camberley Surrey GU15 3HD"
- (r) for the Second Schedule to that Order there was substituted the Second Schedule


