1 THIS Order may be cited as "The Surrey County Council (Various Roads in Godalming and Farncombe in the Borough of Waverley) (Residents' Only On-Street Parking Places) (No. 1) Order 2014 (Amendment No.3) Order 2019" and shall come into operation on 30 September 2019_____

2 (1) In this Order "the Principal Order" means The Surrey County Council (Various Roads in Godalming and Farncombe in the Borough of Waverley) (Residents' Only On-Street Parking Places) (No. 1) Order 2014_____

(2) In this Order the expression "enactment" means any enactment whether public general or local and includes any order byelaw rule regulation scheme or other instrument having effect by virtue of an enactment_____

(3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment

(4) Unless the context otherwise requires any expression used in this Order which is also used in the Principal Order shall have the same meaning as in that Order_____

3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Principal Order shall have effect as though -

- (a) For the Third Part of the First Schedule to the Principal Order there was substituted the items in the First Schedule to this Order_____
- (b) For the Second Schedule to the Principal Order there was substituted the Schedule set out in the Second Schedule to this Order_____
