Citation and commencement

- (3) Unless the context otherwise requires any expression used in this Order which is also used in the Principal Order shall have the same meaning as in that Order\_\_\_\_\_

Amendment of The Principal Order

3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Principal Order shall have effect as though:-

- (b) in the Second Schedule to the Principal Order in columns headed “Drawing Nos.” and “Date Drawn” the letters and numbers “3282/WOK/20039” respectively there be added under the columns headed “Rev’n” and “Date Revised” the letters and
