Citation and commencement

Interpretation

- 2 (1) In this Order "the Principal Order" means The Surrey County Council (Various Roads in Woking) (Consolidation of Free Street Parking Places) (Disabled Persons) Order 2005\_\_\_\_\_
- (2) In this Order the expression "enactment" means any enactment whether public general or local and includes any order bylaw rule regulation scheme or other instrument having effect by virtue of an enactment\_\_\_\_\_
- (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment\_\_\_\_\_
- (4) Unless the context otherwise requires any expression used in this Order which is also used in the Principal Order shall have the same meaning as in that Order\_\_\_\_\_

Amendment of The Principal Order

3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Principal Order shall have effect as though for the Second Schedule to the Principal Order there was substituted the Schedule set out in the Schedule to this Order\_\_\_\_\_
