SURREY COUNTY COUNCIL in exercise of their powers under Sections 1(1) 2(1) to (3) 4(2) 32 35 36 45 46 47 48 49 51 52 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order: -

Citation and commencement

1. THIS Order may be cited as "The Surrey County Council Various Roads in the Borough of Elmbridge (Waiting Loading and Unloading Restriction and On-Street Parking Places Orders) (Amendment No. 2) Order 2023" and shall come into operation on 1 April 2023

Interpretation

2. (1) In this Order the expression "enactment" means any enactment whether public general or local and includes any order bylaw rule regulation scheme or other instrument having effect by virtue of an enactment

(2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment

(3) Unless the context otherwise requires any expression used in this Order which is also used in the respective amended Order shall have the same meaning as in that Order

Amendment of the Principal Orders

3. WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order: -

(1) The Surrey County Council Various Roads in the Borough of Elmbridge (Consolidation and Revocation of Controlled Parking Zones) Order 2021 shall have effect as though –
 (a) For Article 3 of the said Order there was substituted the following similarly numbered Article –

"3 EACH part of a highway comprising either -

(i) the length of carriageway of a road specified on the plans as a residents' only parking

place and unless otherwise so specified bounded on one side of that length by the edge of the carriageway and having a width throughout of no less than 1.8 metres and/or

(ii) the area of highway specified and described in column 3 of the table in the First Schedule to this Order and specified as a Permit Parking Zone in column 3 of the said table

and within the areas marked by a black broken line and labelled as a Controlled Parking Zone is authorised to be used subject to the following provisions of this Order as a residents' parking place for use on such days and during such hours as identified on the aforesaid plans"

(b) For the First Schedule to the said Order there was substituted the First Schedule to this Order

(c) For the Third Schedule to the said Order there was substituted the Fifth Schedule to this Order

(d) For the List of Plans in the Sixth Schedule to the said Order there was substituted the List of Plans in the Fourth Schedule to this Order

(2) The Surrey County Council Various Roads in the Borough of Elmbridge (Consolidation and Revocation of Residents' On-Street Parking Places) Order 2021 shall have effect as though –

(a) The words "comprising those lengths of the carriageway" were omitted from paragraph (ii) of Article 3
