**FARNHAM RAILWAY STATION CONTROLLED PARKING ZONE**  
**(CONSOLIDATION OF WAITING RESTRICTIONS**  
**AND ON-STREET PARKING PLACES) ORDER 2007**  
**(AMENDMENT NO. 13) ORDER 2022**

SURREY COUNTY COUNCIL in exercise of their powers under Sections 1(1) 2(1) to (3) 4(2) 32 3536 45 46 49 51 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order: -

1 THIS Order may be cited as "The Surrey County Council Farnham Railway Station Controlled Parking Zone (Consolidation of Waiting Restrictions and On-Street Parking Places) Order 2007 (Amendment No. 13) Order 2022" and shall come into operation on 1 November 2022\_\_\_\_\_

- 2 (1) In this Order "the Principal Order" means The Surrey County Council Farnham Railway Station Controlled Parking Zone (Consolidation of Waiting Restrictions and On-Street Parking Places) Order 2007\_\_\_\_\_
- (2) In this Order the expression "enactment" means any enactment whether public general or local and includes any order byelaw rule regulation scheme or other instrument having effect by virtue of an enactment\_\_\_\_\_
- (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment
- (4) Unless the context otherwise requires any expression used in this Order which is also used in the Principal Order shall have the same meaning as in that Order\_\_\_\_\_

3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Principal Order shall have effect as though -

**(i)** The following Section was added to Part IV in the Arrangement of Articles immediately following Section II(C) -

"SECTION II(D) – CHILDCARE PARKING PERMITS

Application for and issue of a childcare parking permit..	..	..	..	29(K)
Fee to be paid in respect of a childcare parking permit..	..	..	..	29(L)
Form of childcare parking permit..	..	..	..	29(M)
Display of childcare parking permit..	..	..	..	29(N)”

**(ii)** The following item was added to the Arrangement of Schedules as the fourth item

–

**“FOURTH SCHEDULE                      Cost of Residents Permits”**

**(iii)** The following expressions and interpretations were added to paragraph (1) of Article 2 in alphabetical sequence -

“childcare parking permit” means a childcare parking permit issued by the Borough Council under the provisions of Article 29(K)

“childcare parking permit holder” means a person to whom a childcare parking permit has been issued

“two-hour resident’s visitor’s parking permit” means a resident’s visitor’s parking permit that is limited to a validity of two hours”

**(iv)** The words “and shall include a two-hour resident’s visitor’s parking permit where applicable” were added to the interpretation of the expression “resident’s visitor’s parking permit” in paragraph (1) of Article 2 immediately following the number and letter “29(A)”

**(v)** The words “or as the case may be a childcare parking permit” were added to the interpretation of the expression “permit” in paragraph (1) of Article 2 immediately following the words “carer’s parking permit”

**(vi)** The following sub-paragraph was inserted in paragraph (1) of Article 24 immediately following sub-paragraph (e) –

“(f) Any childcare parking permit shall be included in the calculation herein of a resident’s entitlement to a resident’s parking permit as though it was a resident’s parking permit”

**(vii)** For paragraph (7) of Article 24 there was substituted the following similarly numbered paragraph-

“(7) The fee referred to in paragraph (1) of this Article payable to the Council shall be such sums as are specified in the Fourth Schedule to this Order in respect of such nominated vehicle indicated therein which subject to the provisions of this Order shall be valid for a period of twelve months running from any day of the month on which

the parking permit first becomes valid and shall apply from the date indicated in the relevant column therein

**(viii)** The words “or limited to two hours as the case may be” were inserted in paragraphs (1) and (3) of Article 29(A) immediately following the words “without time limit”

**(ix)** For paragraph (4) of Article 29(A) there was substituted the following similarly numbered paragraph -

(4) Subject to the provisions contained in paragraph (3) of this Article the number of residents’ visitors parking permits issued in respect of each separate place of abode shall not exceed one hundred and fifty in each calendar year and two hundred and fifty two-hour residents’ visitors’ parking permits in each calendar year”

PROVIDED THAT this paragraph shall have effect subject to the proviso that in certain exceptional circumstances the number of residents’ visitor’s parking permits issued in respect of each separate place of abode may exceed one hundred and fifty in each calendar year and two hundred and fifty two-hour residents’ visitors’ parking permits with no upper limit on the number of such permits so issued provided that in each case the exceptional circumstances referred to above are met and/or fully complied with”

**(x)** For paragraph (6) of Article 29(A) there was substituted the following similarly numbered paragraph –

“(6) The fee referred to in paragraph (3) of this Article payable to the Council in respect of -

- (i) a resident’s visitor’s parking permit shall be £2 for each such parking permit and that the resident’s visitor’s parking permit shall be valid for a period of one day only
- (ii) a two-hour resident’s visitor’s parking permit shall be £1 for each such parking permit and that the two-hour resident’s visitor’s parking permit shall be valid for a period of two hours only”

**(xi)** The following paragraph was added to Article 29(B) immediately following paragraph (f) –

“(g) and in the case of a two-hour resident’s visitor’s parking permit a space

for the insertion of the time of the commencement of waiting by the said vehicle in the parking place”

(xii) The words “and in the case of a two-hour resident’s visitor’s parking permit the time of the commencement of waiting by the said vehicle in the parking place” were added to Article 29(D) immediately following the words “to be used” in the last line

(xiii) For Article 29(G) including the shoulder heading there was substituted the following similarly numbered Article –

**“No Charge in respect of a carer’s parking permit**

29(G) NO charge shall be payable in respect of a carer’s parking permit which subject to the provisions of this Order shall be valid for a period of twelve months”

(xiv) Article 29(H) was omitted in its entirety

(xv) The following Section was added to Part IV immediately following Section II(C)

**“SECTION II(D) – CHILDCARE PARKING PERMITS**

**Application for and issue of a childcare parking permit**

29(K) (1) ANY person –

(a) who is resident or ordinarily resident at any premises the postal address of which is in the roads and lengths of roads specified and described in the First Schedule and

(b) who receives regular visits from another person for the purpose of child care pursuant to a contract of employment

may apply to the Council for the issue of a childcare parking permit for the leaving in any residents’ only parking place or shared use parking place situated within the lengths of roads specified in the First Schedule and identified on any of the plans during the permitted hours of either a passenger vehicle or goods vehicle or motor cycle and belonging to or being used by a person visiting that resident at those premises to carry out childcare duties and any such application shall be made either electronically or on a form issued by and obtainable from the Council and shall include the particulars and information required to be supplied and the Council may in its absolute discretion issue a childcare parking permit to such resident

(2) THE Council may at any time require an applicant for a childcare parking permit or a childcare parking permit holder to produce to an

officer of that Council such evidence in respect of an application for a childcare parking permit made to them as they may reasonably call for to verify any particulars or information given to them or in respect of any childcare parking permit issued by them to that person as they may reasonably call for to verify that the childcare parking permit is valid

(3) UPON receipt of an application duly made under the foregoing provisions of this Article and upon being satisfied that the applicant is in need of such visits by a childcare provider who is or are either the owner of either a passenger vehicle or goods vehicle or a motor cycle or a person authorised to use such a vehicle by the owner thereof the Council may in its absolute discretion issue to the applicant therefor one childcare parking permit for the leaving without time limit during the permitted hours in any residents' only parking place or shared use parking place situated within the lengths of roads specified in the First Schedule and identified on any of the plans of a vehicle belonging to or being used by a person visiting that resident in the course of their duties

PROVIDED THAT the childcare parking permit is only valid in respect of any resident's premises that are situated in the roads or parts of the roads specified and described in the First Schedule

(4) IN any respect not specifically mentioned in paragraphs (1), (2) and (3) of this Article and Articles 29(L) 29(M) and 29(N) the procedure validity and terms of use of a childcare parking permit shall be the same as the procedure validity and terms of use of a residents' parking permit and this paragraph shall be construed accordingly

#### **Fee to be paid in respect of a childcare parking permit**

29(L) The fee payable in respect of a childcare parking permit shall be as for a resident's parking permit as specified in the Fourth Schedule and the childcare permit shall be taken into account when making the calculation in accordance with the charges specified in the Fourth Schedule which subject to the provisions of this Order shall be valid for a period of twelve months

#### **Form of childcare parking permit**

29(M) A childcare parking permit shall be in writing and shall include the following particulars –

- (i) a serial number identifiable in the office of issue
- (ii) the word "CHILDCARE"

- (iii) the period during which the childcare parking permit shall remain valid
- (iv) an indication that the childcare parking permit has been issued by the Borough Council
- (v) the appropriate letter identifying the roads or lengths of roads in which the permit is valid

**Display of childcare parking permit**

29(N) AT all times during which a passenger vehicle or a goods vehicle which is being used for the purposes specified in paragraph (1) of Article 29(K) is left in a residents’ only parking place or shared use parking place within the lengths of roads specified in the First Schedule and identified on the plans during the permitted hours a valid childcare parking permit shall be displayed on the vehicle in respect of which it is to be used on the front or near-side of the vehicle so that all the particulars on the childcare parking permit are readily visible from the front or near-side of the vehicle”

**(xvi)** The First Schedule to this Order was added to the Principal Order as the Fourth Schedule

**(xvii)** For the Second Schedule to the Principal Order there was substituted the Schedule set out in the Second Schedule to this Order
