SURREY COUNTY COUNCIL in exercise of their powers under Sections 1(1) 2(1) to (3) 4(2) 32 35 36 45 46 49 51 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order: -

 THIS Order may be cited as "The Surrey County Council Farnham Town Centre Controlled Parking Zone (Consolidation of Waiting Loading and Unloading Prohibitions and Restrictions and On-Street Parking Places) Order 2007 (Amendment No. 14) Order 2023" and shall come into operation on 23 October 2023

- 2. (1) In this Order "the Principal Order" means The Surrey County Council Farnham Town Centre Controlled Parking Zone (Consolidation of Waiting Loading and Unloading Prohibitions and Restrictions and On-Street Parking Places) Order 2007
 - (2) In this Order the expression "enactment" means any enactment whether public general or local and includes any order byelaw rule regulation scheme or other instrument having effect by virtue of an enactment
 - (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated reenacted by or as having effect by virtue of any subsequent enactment
 - (4) Unless the context otherwise requires any expression used in this Order which is also used in the Principal Order shall have the same meaning as in that Order

Amendment of the Principal Order

3. WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Principal Order shall have effect as though -

(1) The following interpretations were added to paragraph (1) of Article 2 in alphabetical order-

""hand held device" is a device used by a civil enforcement officer which is updated from time to time with information on valid and invalid (expired) virtual parking transactions

"virtual parking permit" means a parking permit electronically issued by the Council to a resident or carer or medical or community care personnel or resident's visitor or a business user

"virtual parking transaction" can be a virtual resident parking permit virtual resident visitor parking permit a virtual operational parking permit a virtual carers parking permit a virtual childcare parking permit a virtual business permit or a virtual waiver certificate

"virtual waiver certificate" means a waver certificate that is issued and verified electronically by the Council"

(2) The words "or for which a valid virtual permit is in force for such vehicle" was added to the interpretation of "dual use parking place" and "shared use parking place" and "residents only parking place" in paragraph (1) of Article 2 immediately following the words "that vehicle" in the last line

(3) The interpretation of "Borough Council" in paragraph (1) of Article 2 was omitted in its entirety

(4) For the words "a certificate" in the interpretation of "waiver Certificate" in paragraph (1) of Article 2 there was substituted the words "a paper or virtual certificate"

(5) The following proviso was added to paragraph (b) of Article 12 and paragraph (b) of Article 13 and paragraph (b) of Article 14 and paragraph (2) of Article 44(C) and paragraph (2) of Article 44(D) and Article 44(E) and paragraph (1) of Article 44(F) and Article 44(G) and Article 44(O) and Article 44(R) and Article 53 Article 54(C) and paragraph (7) of Article 54(E) and Article 54(J) and Article 54(N) and Article 54(T) as a proviso -

"PROVIDED THAT in respect of a vehicle which is validated by the hand held device as having a valid virtual parking permit no parking permit needs to be displayed" **(6)** The following proviso was added to paragraph (g) of Article 4 and paragraph (c) of Article 13 and paragraph (c) of Article 14 and sub-paragraph (j) of paragraph (1) of Article 20 and paragraph (b) of Article 25 and paragraph (b) of Article 26 and sub-paragraph (j) of paragraph (1) of Article 32 and sub-paragraph (j) of paragraph (1) of Article 44(M) and sub-paragraph (j) of paragraph (1) of Article 44(X) immediately following the words "the said certificate" -

"PROVIDED THAT a vehicle which is validated by the hand held device as having a valid virtual waiver certificate then no certificate needs to be displayed on that vehicle"

(7) The words "or the Borough Council" and the words "and/or the Borough Council" and the words "the Borough Council or" and the words "and/or Waverley Borough Council of the Council Offices The Burys Godalming Surrey GU7 1HR" and the word "Borough" wherever they appear were omitted in their entirety other than in sib-paragraph (i) of paragraph (1) of Article 44(M)

(8) The words "or by electronic means" were inserted in sub-paragraph (d) of paragraph (1) of Article 49 and paragraph (1) of Article 54(A) and paragraph (1) of Article 54(F) and in paragraph (1) of Article 54(K) and in paragraph (1) of Article 54(K) immediately following the word "Council"

(9) The phrase "either (1)" was inserted in Article 52 and Article 54(B) and paragraph
(6) of Article 54(E) and Article 54(M) and Article 54(S) immediately after the word
"shall"

(10) The following paragraph was added to Article 52 immediately following the existing paragraph –

"(2) or be a virtual resident's parking permit"

(11) The following paragraph was added to Article 54(B) immediately following the existing paragraph –

"(2) or be a virtual resident's visitor's parking permit"

(12) The following paragraph was added to Article 54(E) immediately following the existing paragraph –

"(2) or be a virtual operational parking permit"

(13) The following paragraph was added to Article 54(I) immediately following the existing paragraph –

"(2) or be a virtual carer's parking permit"

(14) The following paragraph was added to Article 54(M) immediately following the existing paragraph –

"(2) or be a virtual business parking permit"

(15) The following paragraph was added to Article 54(S) immediately following the existing paragraph –

"(b) or be a virtual childcare parking permit"

(16) For Article 58 there was substituted the following Article -

"58 The owner of a vehicle in respect of which the penalty charge has been incurred shall pay the penalty charge in accordance with the directions contained in the penalty charge notice"

(17) For the Second Schedule to the Principal Order there was substituted the Schedule set out in the Schedule to this Order
