# THE SURREY COUNTY COUNCIL <br> (VARIOUS ROADS IN GODALMING AND FARNCOMBE IN THE BOROUGH OF WAVERLEY) (RESIDENTS' ONLY ON-STREET PARKING PLACES) <br> (NO. 1) ORDER 2014 

(AMENDMENT NO. 7) ORDER 2023

SURREY COUNTY COUNCIL in exercise of their powers under Sections 323536 45464951 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order: -

1. THIS Order may be cited as "The Surrey County Council (Various Roads in Godalming and Farncombe in the Borough of Waverley) (Residents' Only On-Street Parking Places) (No. 1) Order 2014 (Amendment No. 7) Order 2023" and shall come into operation on 23 October 2023
2. (1) In this Order "the Principal Order" means The Surrey County Council (Various Roads in Godalming and Farncombe in the Borough of Waverley) (Residents' Only On-Street Parking Places) (No. 1) Order 2014
(2) In this Order the expression "enactment" means any enactment whether public general or local and includes any order byelaw rule regulation scheme or other instrument having effect by virtue of an enactment
(3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated reenacted by or as having effect by virtue of any subsequent enactment
(4) Unless the context otherwise requires any expression used in this Order which is also used in the Principal Order shall have the same meaning as in that Order

## Amendment of the Principal Order

3. WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Principal Order shall have effect as though -
(1) The following interpretations were added to paragraph (1) of Article 2 in alphabetical order-
""hand held device" is a device used by a civil enforcement officer which is updated from time to time with information on valid and invalid (expired) virtual parking transactions
"virtual parking permit" means a parking permit electronically issued by the Council to a resident or carer or medical or community care personnel or resident's visitor
"virtual parking transaction" can be a virtual resident parking permit virtual resident visitor parking permit a virtual operational parking permit a virtual carers parking permit a virtual childcare parking permit or a virtual waiver certificate "virtual waiver certificate" means a waver certificate that is issued and verified electronically by the Council"
(2) For the words "a certificate" in the interpretation of "waiver Certificate" in paragraph (1) of Article 2 there was substituted the words "a paper or virtual certificate"
(3) The words "or for which a valid virtual permit is in force for such vehicle" was added to the interpretation of "residents only parking place" and "shared use parking place" in paragraph (1) of Article 2 immediately following the words "that vehicle" in the last line
(4) The interpretation of the expression "Borough Council" in paragraph (1) of Article 2 was omitted in its entirety
(5) The words "or the Borough Council" and the words "and/or the Borough Council" and the words "and/or Borough Council" and the words "the Borough Council" and the words "and the Borough Council" and the word "Borough" wherever they appear were omitted in their entirety other than in the title and in Article 1 and Article 13(J)
(6) The following proviso was added to Article 4 and paragraph (b) of Article 13(B) and paragraph (b) of Article 13(C) and paragraph (b) of Article 13(D) and Article 22 and Article 26 and paragraph (7) of Article 28 and Article 32 and Article 34D as a proviso -
"PROVIDED THAT in respect of a vehicle which is validated by the hand held device as having a valid virtual parking permit no parking permit needs to be displayed"
(7) The following proviso was added to sub-paragraph (i) of paragraph (1) of Article 10 and paragraph (c) of Article 13(C) and paragraph (c) of Article 13(D) subparagraph (j) of paragraph (1) of Article 13(J) immediately following the words "the said certificate" -
"PROVIDED THAT a vehicle which is validated by the hand held device as having a valid virtual waiver certificate then no certificate needs to be displayed on that vehicle"
(8) The words "or by electronic means" was inserted in sub-paragraph (d) of paragraph (1) of Article 17 and paragraph (1) of Article 24 paragraph (1) of Article 29 immediately following the word "Council"
(9) The phrase "either (1)" was inserted in Article 21 and Article 25 and paragraph (6) of Article 28 and Article 32 and Article 34C immediately after the word "shall"
(10) The following paragraph was added to Article 21 immediately following the existing paragraph -
"(2) or be a virtual resident's parking permit"
(11) The following paragraph was added to Article 25 immediately following the existing paragraph -
"(2) or be a virtual resident's visitor's parking permit"
(12) The following paragraph was added to paragraph (6) of Article 28 immediately following the existing paragraph -
"(2) or be a virtual operational parking permit"
(13) The following paragraph was added to Article 32 immediately following the existing paragraph -
"(2) or be a virtual carer's parking permit"
(14) The following paragraph was added to Article 34C immediately following the existing paragraph -
"(2) or be a virtual childcare parking permit"
(15) For Article 37 there was substituted the following Article -
"37 The owner of a vehicle in respect of which the penalty charge has been incurred shall pay the penalty charge in accordance with the directions contained in the penalty charge notice"
(16) For the Second Schedule to the Principal Order there was substituted the Schedule set out in the Schedule to this Order
