The Surrey County Council (Various Roads in Runnymede) (Consolidation of Free Street Parking Places and Loading Bays and Revocation) Order 2016 (Amendment No.8) Order 2023

SURREY COUNTY COUNCIL in exercise of their powers under Sections 32 35 and 36 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order: -

Citation and commencement

1 THIS Order may be cited as "The Surrey County Council (Various Roads in Runnymede) (Consolidation of Free Street Parking Places and Loading Bays and Revocation) Order 2016 (Amendment No.8) Order 2023" and shall come into operation on 16 October 2023

Interpretation

- 2 (1) In this Order "the Principal Order" means The Surrey County Council (Various Roads in Runnymede) (Consolidation of Free Street Parking Places and Loading Bays and Revocation) Order 2016
 - (2) In this Order the expression "enactment" means any enactment whether public general or local and includes any order byelaw rule regulation scheme or other instrument having effect by virtue of an enactment
 - (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated reenacted by or as having effect by virtue of any subsequent enactment_
 - (4) Unless the context otherwise requires any expression used in this Order which is also used in the Principal Order shall have the same meaning as in that Order

Amendment of the Principal Orders

- WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Principal Order shall have effect as though –
- (1) The following interpretations were added to paragraph (1) of Article 2 in alphabetical order-

""hand held device" is a device used by a civil enforcement officer which is updated from time to time with information on valid and invalid (expired) virtual parking transactions

"virtual parking transaction" can be amongst other things a virtual waiver certificate

"virtual waiver certificate" means a waver certificate that is issued and verified electronically"

- (2) For the words "a certificate" in the interpretation of "waiver Certificate" in paragraph (1) of Article 2 there was substituted the words "a paper or virtual certificate"
- **(3)** The interpretation of the expression "Borough Council" in paragraph (1) of Article 2 was omitted in its entirety
- **(4)** The words "or the Borough Council" and the word "Borough" wherever they appear were omitted in their entirety other than in Article 12
- **(5)** The following sub-paragraph was added to paragraph (b) of Article 5 and sub-paragraph (j) of paragraph (1) of Article 12 immediately following the words "the said certificate" -

"PROVIDED THAT a vehicle which is validated by the hand held device as having a valid virtual waiver certificate then no certificate needs to be displayed on that vehicle"

(6) For the First Schedule to the Principal Order there was substituted the First Schedule set out in the Schedule to this Order
