# Various Roads in The Borough of Runnymede (Residents' On-Street Street Parking Places) Order 2016 (Amendment No.10) Order 2024

SURREY COUNTY COUNCIL in exercise of their powers under Sections 32 35 36 45 46 49 51 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order: -

#### Citation and commencement

- 1. THIS Order may be cited as "The Surrey County Council Various Roads in the Borough of Runnymede (Residents' On-Street Parking Places) Order 2016 (Amendment No.10) Order 2024" and shall come into operation on 11 November 2024
- (1) In this Order "the Principal Order" means The Surrey County
  Council Various Roads in the Borough of Runnymede (Residents' OnStreet Parking Places) Order 2016
  - (2) In this Order the expression "enactment" means any enactment whether public general or local and includes any order byelaw rule regulation scheme or other instrument having effect by virtue of an enactment
  - (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated reenacted by or as having effect by virtue of any subsequent enactment
  - (4) Unless the context otherwise requires any expression used in this Order which is also used in the Principal Order shall have the same meaning as in that Order

#### **Amendment of the Principal Order**

**3.** WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Principal Order shall have effect as though -

- (1) For the word "Fifth" in the interpretation of the term "business user" in paragraph (1) of Article 2 and in Article 31G there was substituted the word "First"
- (2) For paragraph (3) of Article 31F there was substituted the following similarly numbered paragraph
  - On receipt of an application duly made under the foregoing "(3) provisions of this Article the Council upon being satisfied that the applicant is a business user and is the owner of a vehicle of the class specified in paragraph (1) of this Article shall issue to the applicant therefor upon receipt of the fee of one hundred and fifty pounds one business parking permit (and a protective cover if applicable for the display therein of that business parking permit the business parking permit) being for the leaving during the permitted hours in a parking space (where such parking space is provided) in a residents' only parking place or shared use parking place or dual-use parking place situated on any road or part of a road specified in column 3 of the table forming the First Schedule and the postal address of the business premises occupied by the aforesaid business user being within the roads or parts of the roads specified in column 2 of the aforesaid table to which such business parking permit relates by the owner of such vehicle or by any person using such vehicle with the consent of the owner

PROVIDED THAT the Council shall not issue a business parking permit to any business user which would be valid during any period during which any residents' parking permit issued to that business user and relating to the vehicle in question is or would be valid AND PROVIDED ALSO THAT officers of the Council have the absolute discretion to permit the issue of extra business parking permits where it

(3) The following paragraph was added to Article 31F immediately following paragraph (4)

is considered special circumstances exist"

- "(5) The number of business parking permits that may be issued by the Council in respect of each separate business shall be calculated as the sum of the number of vehicles registered to business users therein minus the total number of off-street parking spaces available to that business premises"
- **(4)** For the Second Schedule to the Principal Order there was substituted the Schedule set out in the Schedule to this Order
- (5) The Fifth Schedule to the Principal Order was omitted in its entirety
