(Residents' On-Street Street Parking Places) Order 2016
(Amendment No. 9) Order 2023

SURREY COUNTY COUNCIL in exercise of their powers under Sections 32 35 36 45 46 49 51 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order: -

Citation and commencement

1 THIS Order may be cited as "The Surrey County Council Various Roads in the Borough of Runnymede (Residents' On-Street Parking Places) Order 2016 (Amendment No. 9) Order 2023" and shall come into operation on 16 October 2023

2 (1) In this Order "the Principal Order" means The Surrey County Council Various Roads in the Borough of Runnymede (Residents' On-Street Parking Places) Order 2016

(2) In this Order the expression "enactment" means any enactment whether public general or local and includes any order byelaw rule regulation scheme or other instrument having effect by virtue of an enactment

(3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment

(4) Unless the context otherwise requires any expression used in this Order which is also used in the Principal Order shall have the same meaning as in that Order

Amendment of the Principal Order

3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Principal Order shall have effect as though -

(1) The following interpretations were added to paragraph (1) of Article 2 in alphabetical order-

“virtual parking permit” means a parking permit electronically issued by the Council to a resident or carer or medical or community care personnel or resident’s visitor or business user

“virtual parking transaction” can be a virtual resident parking permit virtual resident visitor parking permit a virtual operational parking permit a virtual carers parking permit a virtual childcare parking permit or a business parking permit or a virtual waiver certificate

“virtual waiver certificate” means a waiver certificate that is issued and verified electronically”

(2) For the interpretation of the expression of “cashless parking transaction“ in paragraph (1) of Article 2 there was substituted the following –

“cashless parking transaction” is a parking permit or a waiver certificate issued via the cashless parking system and/or the telephone payment parking system”

(3) For the words “a certificate” in the interpretation of “waiver Certificate” in paragraph (1) of Article 2 there was substituted the words “a paper or virtual certificate”

(4) The interpretation of the expression “Borough Council” in paragraph (1) of Article 2 was omitted in its entirety

(5) The words “or Borough Council” and the words “and/or Borough Council” and the words “or the Borough Council” and the word “Borough” wherever they appear were omitted in their entirety other than in the title and in Article 1 and Article 14 and in the Third Schedule

(6) The words “or for which a valid virtual permit is in force for such vehicle” was added to the interpretation of “dual use parking place” immediately following the phrase “Article 8B” and “shared use parking place” immediately following the phrase “Article 6” and “residents parking place” immediately following the words “that vehicle” in the last line in paragraph (1) of Article 2

(7) The following proviso was added to Article 4 and paragraph (b) of Article 6 and paragraph (b) of Article 7 and paragraph (a) of Article 8 and paragraph (b) of Article 8B and Article 8C and Article 8D and Article 8F and Article 25 and Article 29 and

paragraph (7) of Article 31 and Article 31H and Article 31I and Article 31M immediately following the words “that vehicle” and in Article 31E immediately following the words “the vehicle” -

“PROVIDED THAT in respect of a vehicle which is validated by the hand held device as having a valid virtual parking permit no parking permit needs to be displayed”

(8) The following proviso was added to paragraph (c) of Article 7 paragraph (c) of Article 8 sub-paragraph (j) of paragraph (1) of Article 14 immediately following the words “the said certificate” -

“PROVIDED THAT a vehicle which is validated by the hand held device as having a valid virtual waiver certificate then no certificate needs to be displayed on that vehicle”

(9) The words “or by electronic means in the case of a virtual resident’s parking permit” was inserted in paragraph (1) of Article 27 immediately following the word “Council”

(10) The phrase “either (1)” was inserted in Article 24 and Article 28 and paragraph (6) of Article 31 and Article 31D and Article 31G and Article 31H and Article 31L immediately after the word “shall”

(11) The phrase “either (i)” was inserted in paragraph (6) of Article 31 immediately after the word “shall”

(12) The following paragraph was added to Article 24 immediately following the existing paragraph –

“(2) or be a virtual resident’s parking permit”

(13) The following paragraph was added to Article 28 immediately following the existing paragraph –

“(2) or be a virtual resident’s visitor’s parking permit”

(14) The following paragraph was added to paragraph (6) of Article 31 immediately following the existing paragraph –

“(ii) or be a virtual operational parking permit”

(15) The following paragraph was added to Article 31D immediately following the existing paragraph –

“(2) or be a virtual carer’s parking permit”

(16) The following paragraph was added to Article 31G immediately following the existing paragraph –

“(2) or be a virtual business parking permit”

(17) SECTION V – CHILDCARE PARKING PERMITS” was relabelled “SECTION VI” wherever it appears

(18) In SECTION IV – CHILDCARE PARKING PERMITS Articles 31F and 31G and 31 H and 31I were renumbered 31J and 31K and 31L and 31M respectively

(19) For the number and letter “31F” in the interpretation of “childcare parking permit in paragraph (1) of Article 2 there was substituted “31J”

(20) For the number and letter “31I” in Article 6 and Article 7 and Article 8 and Article 29 and paragraph (7) of Article 31 there was substituted “31M”

(21) For the phrase “31I” in Article 31E there was substituted the phrase “31H and Article 31M”

(22) The following paragraph was added to Article **31L** immediately following the existing paragraph –

“(2) or be a virtual childcare parking permit”

(23) For the First Schedule to the Principal Order there was substituted the Schedule set out in the First Schedule to this Order

(24) For the Second Schedule to the Principal Order there was substituted the Schedule set out in the Second Schedule to this Order

(25) For the Fourth Schedule to the Principal Order there was substituted the Schedule set out in the Third Schedule to this Order

(26) For the Fifth Schedule to the Principal Order there was substituted the Schedule set out in the Fourth Schedule to this Order
