SURREY COUNTY COUNCIL in exercise of their powers under Sections 32 35 36 45 46 47 48 49 51 52 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order: -

**Citation and commencement**

1. THIS Order may be cited as "The Surrey County Council Sandrock (D5523) Haslemere in the Borough of Waverley (Restricted Zone) (On-Street Parking Place) Order 2013 (Amendment No. 3) Order 2025" and shall come into operation on 28 July 2025

**Interpretation**

2. (1) In this Order the expression –  
“enactment” means any enactment whether public general or local and includes any order bylaw rule regulation scheme or other instrument having effect by virtue of an enactment\_\_\_\_\_

“Principal Order” means The Surrey County Council Sandrock (D5523) Haslemere in the Borough of Waverley (Restricted Zone) (On-Street Parking Place) Order 2013

(2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment\_\_\_\_\_

(3) Unless the context otherwise requires any expression used in this Order which is also used in the amended Order shall have the same meaning as in that Order\_\_\_\_\_

**Amendment of the Principal Orders**

3. WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Principal Order shall have effect as though –

(1) The interpretation of the expression “Borough Council” in paragraph (1) of Article 2 was omitted in its entirety

(2) The word “Borough” and the phrase “or the Borough Council” and the phrase “the Borough Council” and the phrase “and/or the Borough Council” were omitted in their entirety wherever

they appear in the Order save for in the title and in Article 1

(3) For Article 38 there was substituted the following Article -

“38 The owner of a vehicle in respect of which the penalty charge has been incurred shall pay the penalty charge in accordance with the directions contained in the penalty charge notice”
