

THE KENT COUNTY COUNCIL
(VARIOUS ROADS, BOROUGH OF SWALE)
(WAITING RESTRICTIONS AND STREET PARKING PLACES)
(AMENDMENT No 10) ORDER 2020

The Kent County Council, acting as the local traffic authority and in exercise of its powers and under Sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 44, 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984 ('the Act') and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

A – This Order may be cited as "The Kent County Council (Various Roads, Borough of Swale) (Waiting Restrictions and Parking Places) Amendment No.10" ('this Order') and shall come into force on the 23rd day of March 2020.

B - "The Kent County Council (Various Roads, Borough of Swale) (Traffic Regulation and Street Parking Places) (Consolidation) Order 2019" ('the Order') shall have effect as though:

Roads in Queenborough in the Borough of Swale

The following entry is to replace the existing entries to the First Schedule of the Order of 2019

MAIN ROAD

(1) On the southern side

(a) from the Junction of Rushenden Road, to a point 58 metres west of the western kerbline of Gordon Avenue;

(b) from the western kerbline of Gordon Avenue for a distance of 5 metres in a westerly direction;

(c) from the eastern kerbline of Gordon Avenue for a distance of 5 metres in an easterly direction;

(d) from the eastern kerbline of Harold Street for a distance of 5 metres in an easterly direction;

(e) from the western kerbline of Harold Street for a distance of 5 metres in a westerly direction;

(f) from the eastern kerbline of Stanley Avenue for a distance of 5 metres in an easterly direction;

(g) from the western kerbline of Stanley Avenue for a distance of 5 metres in a westerly direction.

(2) On the northern side

(a) from the eastern kerbline of Castlemere Avenue for a distance of 12 metres in an easterly direction;

- (b) from the western kerbline of Castlemere Avenue for a distance of 12 metres in a westerly direction;
- (c) from the eastern kerbline of Dumergue Avenue for a distance of 5 metres in an easterly direction;
- (d) from the western kerbline of Dumergue Avenue for a distance of 5 metres in a westerly direction;
- (e) from the western kerbline of Sterling Road to a point in line with the boundary of 7 Main Road and the Post Office;
- (f) from the eastern kerbline of Sterling Road for a distance of 14 metres in an easterly direction;
- (g) from a point 58 metres west of the western kerbline of Gordon Avenue for a distance of 43 metres in a westerly direction.
