
**THE KENT COUNTY COUNCIL (VARIOUS ROADS, BOROUGH OF SWALE)
(WAITING RESTRICTIONS AND STREET PARKING PLACES)
(AMENDMENT No.16) ORDER 2020**

The Kent County Council, acting as the local traffic authority and in exercise of its powers under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984, ('the Act') and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

A - This Order may be cited as "The Kent County Council (Various Roads, Borough of Swale) (Waiting Restrictions and Street Parking Places) (Amendment No.16) Order 2020" ('this Order') and shall come into force on the 12th day of October 2020.

B - The "Kent County Council (Various Roads, Borough of Swale) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2019" ('the 2019 Order') shall have effect as though -

In the Schedules to the 2019 Order

FIRST SCHEDULE

Roads in Faversham

Alder Close, Oare

The following shall be inserted in the First Schedule of the 2019 Order (*No Waiting At Any Time*) in the correct alphabetical sequence:-

ALDER CLOSE, OARE On the southwestern side, from a point in line with the north-western kerbline of the north-easterly spur of Ham Road, for a distance of 7 metres in a north-westerly direction.

Ham Road, Oare

The following shall be inserted in the First Schedule of the 2019 Order (*No Waiting At Any Time*) in the correct alphabetical sequence:-

HAM ROAD, OARE (1) On both sides

(a) from the centre of the Junction of the northeast spur of Ham Road, for a distance of 14.5 metres in a northerly direction;

(b) from the centre of the Junction of the northeast spur of Ham Road, for a distance of 44 metres in a southerly and south-westerly direction.

(2) On the northern and north-western side of the north-easterly spur of Ham Road

(a) from a point in line with the eastern kerbline of Ham Road for a distance of 36 metres in an easterly and north-easterly direction;

(b) from the centre of the Junction of Alder Close, for a distance of 15 metres in a south-westerly direction;

(3) On the southern and south-easterly side of the north-easterly spur of Ham Road, from a point in line with the eastern kerblineline of Ham Road, east and northeast to a point 9 metres northeast of the centre of the Junction of Alder Close.
