

**THE KENT COUNTY COUNCIL (VARIOUS ROADS, BOROUGH OF SWALE)
(WAITING RESTRICTIONS AND STREET PARKING PLACES)
(AMENDMENT No.20) ORDER 2020**

The Kent County Council, acting as the local traffic authority and in exercise of its powers under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984, ('the Act') and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

A - This Order may be cited as "The Kent County Council (Various Roads, Borough of Swale) (Waiting Restrictions and Street Parking Places) Amendment No.20 Order 2020" ('this Order') and shall come into force on the 7th day of June 2021.

B - The "Kent County Council (Various Roads, Borough of Swale) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2019" ('the 2019 Order') shall have effect as though -

PART B – PROHIBITIONS ON WAITING

PROHIBITION ON WAITING BY MOTOR CARAVANS

The following shall be inserted in the Table of Article 6 of the 2019 Order (*Prohibition on Waiting by Motor Caravans*) in place of the existing entry:-

PART C – PROHIBITION ON STOPPING OUTSIDE SCHOOLS

INTERPRETATION

The following shall be inserted in Article 12 of the Interpretation of Part C of the 2019 Order (*Prohibition on Stopping Outside Schools*) in place of the existing entry:-

12 In this Part of the Order,

"Specified Hours" means between 8.30am and 9.30am or between 2.30pm and 5.00pm on Mondays to Fridays;

"School Day" has the same meaning as in section 579(1) of the Education Act 1996.

"School Entrance Marking" means an area of Carriageway of a Specified Road which is comprised within the Road marking prescribed in Diagram 1027.1 in Schedule 6 of the Traffic Signs Regulations and General Directions 2002, and indicated by the sign prescribed in diagram 642.2A in Schedule 2 of the Traffic Signs Regulations and General Directions 2002.

"Specified Road" means any Road or length of Road or side of Road specified in the Eighth Schedule to this Order.

 - (b) from a point in line with the southern building wall of 57 Abbey Street to a point 5 metres southwest of the north-eastern building line of 58 Abbey Street;
 - (c) between points 20 metres south-west and 20 metres north-east of the centre of the Junction with Abbey Place.
 - (2) On the western side
 - (a) from the Junction with Quay Lane to a point 3 metres north-east of the boundary of 3-4 Abbey Street;
 - (b) between points 20 metres south-west and 20 metres north-east of the centre of the Junction with Abbey Place;
 - (c) from a point 18 metres north-east of the southern boundary of 50 Lammas Gate to the Junction with Abbey Road;
 - (d) from a point in line with the southern building wall of 1 Lammas Gate to a point in line with the boundary of 42-43 Lammas Gate.

Bob Amor Close

 - (a) from the Junction with Whitstable Road to a point in line with the rear boundary of 16 Whitstable Road;
 - (b) from a point 2 metres north of the boundary of 27/28 Bob Amor Close, in a northern and easterly direction to a point 2 metres west of the boundary of 18/19 Bob Amor Close.
 - (2) On the western side
 - (a) from the Junction with Whitstable Road for a distance of 7 metres in a north-easterly direction;
 - (b) from a point 2 metres north of the boundary of 27/28 Bob Amor Close, in a northerly and westerly direction to a point in line with the boundary of 16/17 Bob Amor Close.

Dark Hill

The following shall be inserted in the First Schedule of the 2019 Order (*No Waiting At Any Time*) in place of the existing entry:-

- DARK HILL**
- (1) On the north-eastern side
 - (a) from a point 14 metres north-west of the centre of Davington Hill to a point 16 metres south-east of the centre of Davington Hill;
 - (b) from a point 5 metres northwest of the rear boundary of 1 Davington Hill for a distance of 19 metres in a north-westerly direction.
 - (2) On the south-western side from a point 6.5 metres northwest of the south-eastern boundary of 1 Dark Hill to a point in line with the boundary of 3/5 Dark Hill.

Gordon Square

The following shall be inserted in the First Schedule of the 2019 Order (*No Waiting At Any Time*) in place of the existing entry:-

- GORDON SQUARE (CONTINUATION OF CYPRUS ROAD)**
- (1) On the western side from the boundary with Cyprus Road to a point in line with the boundary of 64-63 Cyprus Road.
 - (2) On the eastern side
 - (a) from the northern kerbline of Gordon Square (southern east-west section) for a distance of 3 metres in a north-easterly direction;
 - (b) from the southern kerbline of the northern east-west section of Gordon Square for a distance of 4 metres in a southerly direction..

GORDON SQUARE (CONTINUATION OF WESTGATE ROAD)

On the eastern side

- (a) from Junction with Luton Road for a distance of 5 metres in a northerly direction;
- (b) from a point in line with the northern building line of 6 Sommerville Close for a distance of 8 metres in a northerly direction.

GORDON SQUARE (NORTHERN EAST-WEST SECTION)

On the southern side, from the eastern kerbline of Gordon Square for a distance of 4 metres in an easterly direction.

GORDON SQUARE (SOUTHERN EAST-WEST SECTION)

On both sides

(a) from the Junction with Cyprus Road for a distance of 10 metres in a south-easterly direction;

(b) from the Junction with Westgate Road for a distance of 3 metres in a north-westerly direction.

Love Lane

The following shall be inserted in the First Schedule of the 2019 Order (*No Waiting At Any Time*) in place of the existing entry:-

(1) On the west side

(a) from the southern kerbline of Whitstable Road to a point in line with the main southerly building line of 2 Love Lane;

(b) between points 52 metres north and 34 metres south of the centre of the vehicular entrance to Love Lane cemetery;

(c) from a point in line with the northern boundary of 75-89 Love Lane for a distance of 25 metres in a southerly direction;

(d) between points 19 metres north of the northern kerbline of Windermere and 18 metres south of the southern kerbline of Windermere

(2) On the east side, from the southern kerbline of Graveney Road to a point opposite the main southerly building line of 2 Love Lane.

Stonebridge Way

 - (b) from a point in line with the boundary of 43-43a West Street in a westerly direction to a point 10 metres north west of the north west boundary of Twyman's Mill;
 - (c) from the western kerbline of Market Place west to a point in line with the boundary of 121/122 West Street.
 - (3) On the north-eastern side from the centre of the Junction with Davington Hill for a distance of 20 metres in a south-easterly direction.
 - (4) On the southern side
 - (a) from the Junction with North Lane in a westerly direction to a point in line with the boundary of 34-35 West Street;
 - (b) from a point in line with the boundary of 39-39a West Street to a point 10 metres north west of the north west boundary of Twyman's Mill.
 - (4) On the south-western side
 - (a) from the south east kerbline of Stonebridge Way for a distance of 10 metres in a south-easterly direction;
 - (b) from the north west kerbline of Stonebridge Way for a distance of 13 metres in a north-westerly direction.

- (1) On the southern side for the full length.
 - (2) On the northern side
 - (a) from the Junction with The Broadway to a point opposite the western boundary of 1 The Leas;
 - (b) between points opposite 1 metre and 9 metres east of the boundary of 1/2 The Leas.

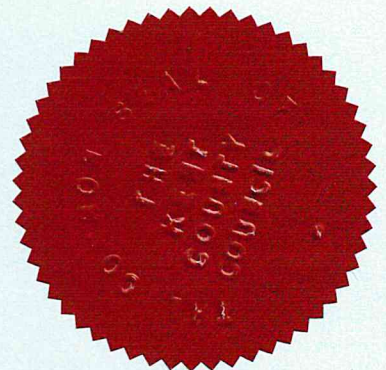
