

THE KENT COUNTY COUNCIL
(VARIOUS ROADS, BOROUGH OF SWALE)
(WAITING RESTRICTIONS AND STREET PARKING PLACES)
(AMENDMENT No.26)
ORDER 2021

The Kent County Council, acting as the Local Traffic Authority and in exercise of its powers and under Sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 44, 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984 ('the Act') and all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby to make the following Order:-

A – This Order may be cited as "The Kent County Council (Various Roads, Borough of Swale) (Waiting Restrictions and Street Parking Places) Amendment No.26" ("this Order") and shall come into force on the 10th day of November 2023.

B - "The Kent County Council (Various Roads, Borough of Swale) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2019" ("the Order of 2019") shall have effect as though-

In the Schedule to the Order of 2019

FIRST SCHEDULE

Roads in Faversham in the Borough of Swale

The following to be inserted in the First Schedule of the Order of 2019 in correct alphabetical sequence:-

NEW GARDENS ROAD, TEYNHAM

On both sides of the junction with Station Road for a distance of 12 meters in a westerly direction.

The following to be inserted to the First Schedule of the Order of 2019 in place of the existing entry:-

STATION ROAD, TEYNHAM

(1) On the south-eastern side

(a) from the Junction with London Road to a point 2 metres south of the boundary of 20/22 Station Road.

(b) from a point in line with the boundary of 26/28 Station Road for a distance of 10.55 metres in a north easterly direction;

(c) from a point in line with the boundary of 42 Station Road for a distance of 21 metres in a southerly direction;

(d) from a point in line with the boundary of 44 Station Road for a distance of 39.5 metres in a northerly direction;

(e) between points 2 metres south-west of the boundary of 80-82 Station Road and 30 metres north-east of the northern kerbline of Belle Friday Close.

(2) On the north-western side

(a) from the Junction with London Road for a distance of 160 metres in a northerly direction;

(b) from a point opposite and in line with the northern kerbline of Noble Close for a distance of 39.5 metres in a southerly direction;

(c) from the Junction with Belle Friday Close to a point 30 metres north-east of the northern kerbline of Belle Friday Close.
