THE KENT COUNTY COUNCIL (VARIOUS ROADS, BOROUGH OF SWALE) (WAITING RESTRICTIONS AND STREET PARKING PLACES) (AMENDMENT No.29) ORDER 2021

The Kent County Council, acting as the local traffic authority and in exercise of its powers under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984, ('the Act') and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- A This Order may be cited as "The Kent County Council (Various Roads, Borough of Swale) (Waiting Restrictions and Street Parking Places) Amendment No.29 Order 2021" ('this Order') and shall come into force on the 20th day of December 2021.
- B The "Kent County Council (Various Roads, Borough of Swale) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2019" ('the 2019 Order') shall have effect as though -

FIRST SCHEDULE

Roads in Eastchurch in the Borough of Swale

High Street

The following shall be inserted in the First Schedule of the 2019 Order (No Waiting At Any Time) in place of the existing entry:-

HIGH STREET, EASTCHURCH

- (1) On the southern side
- (a) from a point 33 metres west of the western kerbline of Cheyne Road, east to a point in the line with the boundary of 56/58 High Street;
- (b) from the eastern kerbline of Church Road for a distance of 7 metres in an easterly direction
- (c) from the western kerbline of Squires Court for a distance of 30 metres in a westerly direction to the western end of the lay-by;
- (d) from the eastern kerbline of Squires Court east to a point in line with the western boundary of 24 High Street.
- (2) On the northern side
- (a) between the western and eastern boundaries of 45 High Street;
- (b) from a point in line with the eastern boundary of 7 Spitfire Mews, High Street, to a point 13 metres east of the eastern boundary of 11c High Street.

- (1) On the north-western side, from the south-western kerbline of Attlee Way for a distance of 13 metres in a south-westerly direction.
- (2) On the south-eastern side, from the south-western kerbline of Attlee Way for a distance of 8 metres in a south-westerly direction.


