THE KENT COUNTY COUNCIL

(VARIOUS ROADS, BOROUGH OF SWALE) (WAITING RESTRICTIONS AND STREET PARKING PLACES) (AMENDMENT No.30) ORDER 2022

The Kent County Council, acting as the Local Traffic Authority and in exercise of its powers and under Sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 44, 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984 ('the Act') and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

A – This Order may be cited as "The Kent County Council (Various Roads, Borough of Swale) (Waiting Restrictions and Street Parking Places) (Amendment No.30) Order 2022" ('this Order') and shall come into force on the 21st day of November 2022.

B - "The Kent County Council (Various Roads, Borough of Swale) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2019" ('the Order of 2019') shall have effect as though-

In the Schedule to the Order of 2019

FIRST SCHEDULE

Roads in Faversham in the Borough of Swale

The following to be inserted to the First Schedule of the Order of 2019 in place of the existing entry:-

DARK HILL

- (1) On the north-eastern side
- (a) from its junction with Davington Hill for a distance of 3 metres in a north westerly direction;
- (b) from a point 35 metres northwest of the junction with Davington Hill for a distance of 20 metres in a north westerly direction.
- (2) On the south-western from its junction with West Street for a distance of 17 metres in a north westerly direction.

The following to be inserted to the First Schedule of the Order of 2019 in place of the existing entry:-

WEST STREET

- (1) On both sides between its Junctions with Market Street and North Lane.
- (2) On the northern side
- (a) from the Junction with North Lane in a westerly direction to a point in line with the western boundary of 93 West Street;
- (b) from a point opposite and in line with the boundary of 43-43a West

Street in a westerly direction to a point 29 metres northwest of the north west boundary of Twyman's Mill;

- (c) from the western kerbline of Market Place west to a point in line with the boundary of 121/122 West Street.
- (3) On the north-eastern side its junction with Davington Hill for a distance of 13 metres in a south-easterly direction;
- (4) On the southern side
- (a) from the Junction with North Lane in a westerly direction to a point in line with the boundary of 34-35 West Street;
- (b) from a point in line with the boundary of 39-39a West Street to a point 29 metres northwest of the northwest boundary of Twyman's Mill.
- (4) On the south-western side
- (a) from the southeast kerbline of Stonebridge Way for a distance of 10 metres in a south-easterly direction;
- (b) from the northwest kerbline of Stonebridge Way for a distance of 13 metres in a north-westerly direction;
- (c) from its junction with Dark Hill for a distance of 8 metres in a south easterly direction.
