**THE KENT COUNTY COUNCIL (VARIOUS ROADS, BOROUGH OF SWALE)  
(WAITING RESTRICTIONS AND STREET PARKING PLACES)  
(AMENDMENT No.33) ORDER 2022**

The Kent County Council, acting as the local traffic authority and in exercise of its powers under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984, ('the Act') and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

A - This Order may be cited as "The Kent County Council (Various Roads, Borough of Swale) (Waiting Restrictions and Street Parking Places) Amendment No.33 Order 2022" ('this Order') and shall come into force on the 9th day of September 2022.

B - The "Kent County Council (Various Roads, Borough of Swale) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2019" ('the 2019 Order') shall have effect as though -

**In the Schedules to the 2019 Order**

**FIRST SCHEDULE**

**Roads in Sittingbourne and Milton**

**Blaxland Grange, Newington**

The following shall be inserted in the First Schedule of the 2019 Order (*No Waiting At Any Time*) in the correct alphabetical sequence:-

**BLAXLAND GRANGE, NEWINGTON**

On both sides, from a point in line with the north-eastern kerbline of School Lane for a distance of 8 metres in a north-easterly direction.

**School Lane, Newington**

The following shall be inserted in the First Schedule of the 2019 Order (*No Waiting At Any Time*) in the correct alphabetical sequence:-

**SCHOOL LANE, NEWINGTON**

On the north-eastern side

(a) from a point in line in the south-eastern kerbline of Blaxland Grange for a distance of 22 metres in a south-easterly direction;

(b) from a point in line with the north-westerly kerbline of Blaxland Grange for a distance of 39 metres in a north-westerly direction.

## EIGHTH SCHEDULE


The following shall be inserted in the Eighth Schedule of the 2019 Order (*Prohibition of Stopping Outside Schools*) in place of the existing entry:-

Roads in Sittingbourne and Milton	
Road	Length of Road
SCHOOL LANE, NEWINGTON	On the south-western side  (a) across the frontage of Newington C of E Primary School and 15-17 School Lane;  (b) from a point 39 metres northwest of the north-western kerbline of Blaxland Grange for a distance of 63 metres in a south-easterly direction.
