

THE KENT COUNTY COUNCIL (VARIOUS ROADS, BOROUGH OF SWALE) (WAITING RESTRICTIONS AND STREET PARKING PLACES) (AMENDMENT No.15) ORDER 2020

The Kent County Council, acting as the local traffic authority and in exercise of its powers under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984, ('the Act') and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

A - This Order may be cited as "The Kent County Council (Various Roads, Borough of Swale) (Waiting Restrictions and Street Parking Places) Amendment No.15 Order 2020" ('this Order') and shall come into force on the 14th day of September 2020.

B - The "Kent County Council (Various Roads, Borough of Swale) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2019" ('the 2019 Order') shall have effect as though -

INTERPRETATION

The following text shall be inserted into Article 2 of the 2019 Order in the correct alphabetical sequence:-

"Electric Vehicle" unless the context otherwise requires, means a vehicle designed and constructed to be propelled by electricity, supplied by a battery or other form of electrical cell or reservoir.

"Electric Vehicle Charging Bay" means a parking bay which has been marked as intended for the exclusive use of an electrical vehicle whilst the said vehicle is being charged and has provided to the bay, an electrical vehicle charging point, and is appropriately signed.

"Electric Vehicle Charging Point" means a purpose-built unit designed specifically for charging electric vehicles.

"Hybrid Electrically Propelled Vehicle" means a vehicle primarily powered by an electrical storage battery.

The following text shall be inserted into Part F of the 2019 Order as item 31b:-

31b SAVE as provided in Part G of this Order no person shall, except upon the direction or with permission of a police constable in uniform or of a Parking Attendant, cause or permit any vehicle, other than an Electric Taxi Charging Vehicle to wait at any time in any of the parking places described in the Ninth Schedule to this Order.

In the Schedules to the Order

FIRST SCHEDULE

The following shall be inserted in the First Schedule of the 2019 Order (No Waiting At Any Time) in place of the existing entry:-

CENTRAL AVENUE

- (1) On the eastern side
- (a) from the Junction with Avenue of Remembrance for a distance of 31 metres in a northerly direction;
- (b) from a point 13 metres south of the northern building line of Wyvern Hall for a distance of 13 metres in a southerly direction;
- (c) from a point 5 metres south of the northern building line of Wyvern Hall to the southern kerbline of High Street.
- (2) On the western side
- (a) from the Junction with Avenue of Remembrance for a distance of 70 metres in a northerly direction;
- (b) from a point 97 metres north of the northern kerbline Avenue of Remembrance to a point 106 metres north of the northern kerbline of Avenue of Remembrance;
- (c) from a point 141 metres north of the northern kerbline of Avenue of Remembrance to a point 56 metres south of the southern kerbline of High Street;
- (d) from the southern boundary line of the church, north to the Junction with High Street.

The following Schedule, Ninth Schedule (*Electric Taxi Charging Places*), shall be inserted into the 2019 Order in the correct numerical sequence:-
