

**THE KENT COUNTY COUNCIL (VARIOUS ROADS, BOROUGH OF SWALE)
(WAITING RESTRICTIONS AND STREET PARKING PLACES)
(AMENDMENT No.18) ORDER 2020**

The Kent County Council, acting as the local traffic authority and in exercise of its powers under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984, ('the Act') and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

A - This Order may be cited as "The Kent County Council (Various Roads, Borough of Swale) (Waiting Restrictions and Street Parking Places) (Amendment No.18) Order 2020" ('this Order') and shall come into force on the 22nd day of February 2021.

B - The "Kent County Council (Various Roads, Borough of Swale) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2019" ('the 2019 Order') shall have effect as though -

PART B – PROHIBITIONS ON WAITING

The following shall be inserted in Part B of the 2019 Order (*Prohibition on Waiting*) in place of the existing entry:-

PROHIBITION ON WAITING BY MOTOR CARAVANS

6 SAVE as provided in Part G of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or of a Parking Attendant, cause or permit any motor caravan to wait in any of the lengths of Restricted Road described in columns 2 and 3 of any item in the Table (Article 6) on the days and times specified in the corresponding column 4.

The following shall be inserted in Part B Table (Article 6) of the 2019 Order (Prohibition on Waiting by Motor Caravans) in place of the existing Table:-

The following shall be inserted in the First Schedule of the 2019 Order (*No Waiting At Any Time*) in place of the existing entry:-

- ASHFORD ROAD
- (1) On the eastern side
 - (a) between points 30 metres north and 30 metres south of the access Road to the south of 141 Ashford Road;
 - (b) between a point 24 metres north of the Junction with the Coast Bound M2 slip Road to a point 18 metres south of that Junction.
 - (2) On the western side, from a point opposite the southern boundary of 93 Ashford Road north to the junction with the roundabout to Tettenhall Way.

Roads in Eastchurch in the Borough of Swale

Court Tree Drive, Eastchurch

The following shall be inserted in the First Schedule of the 2019 Order (*No Waiting At Any Time*) in the correct alphabetical sequence:-

COURT TREE DRIVE, EASTCHURCH

- (1) On the northwest side of the Road, from the radius kerb of the roundabout on Eastchurch Road to a point 6 metres south of the southern kerbline of Coultrip Close.
- (2) On the southeast side of the Road, from the radius kerb of the roundabout on Eastchurch Road to a point 2 metres south of the southern kerbline of Coultrip Close.
