**ORDER 2011**

---

**THE COUNCIL OF THE CITY AND COUNTY OF SWANSEA** (hereinafter called "the Council") in exercise of its powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 (as amended) (which said Act of 1984 is hereby referred to as "the Act of 1984") and the Traffic Management Act 2004 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Section 124 of the Act of 1984 hereby make the following Order:

1. **THIS** Order shall come into operation on the 28<sup>th</sup> day of April 2011 and may be cited as "the Council of the City and County of Swansea (Revocations) (Prohibition of Driving)(Old Carmarthen Road, Swansea) Order 2011"
2. **IN** this Order:
  - 2.1. **EXCEPT** where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order
  - 2.2. **THE** Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament
  - 2.3. **THE** prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation of any other prohibition or restriction whether made under the Act of 1984 or otherwise

3. The existing Orders are revoked insofar as they are inconsistent with the provisions contained in the Schedules hereto and insofar as they relate to the length or lengths of the road or roads referred to in the Schedules hereto
4. Nothing in Article 7 shall relate to a police fire ambulance or other emergency vehicle being used for emergency purposes
5. Save as provided in Article 4 and except on the direction of a police officer in uniform or for access to any adjoining property, no person shall cause any vehicle to be driven along the length or lengths of the road referred to in the Schedule hereto

## **SCHEDULE**

### **SCHEDULE 1**

#### **REVOCATION**

The existing Orders are revoked insofar as they are inconsistent with the provisions contained in the Schedule hereto and insofar as they relate to the length or lengths of the roads or roads referred to in the Schedule below.

### **SCHEDULE 2**

#### **PROHIBITION OF DRIVING**

##### **CARMARTHEN ROAD**

Across its entire length

From a point 12.5 metres south west to a point 14 metres south west of the frontage of the property known as No.582 Carmarthen Road.
