**ORDER 2011**

**THE COUNCIL OF THE CITY AND COUNTY OF SWANSEA** (hereinafter called “the Council”) in exercise of its powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 (as amended) (which said Act of 1984 is hereby referred to as “the Act of 1984”) and the Traffic Management Act 2004 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Section 124 of the Act of 1984 hereby make the following Order:

1. **THIS** Order shall come into operation on Thursday, the 28<sup>th</sup> day of April 2011 and may be cited as “the Council of the City and County of Swansea (Prohibition of Driving) (Unnamed Access Road Adjacent to Mynydd Newydd Road, Ravenhill, Swansea) Order 2011”
2. **IN** this Order:
  - 2.1. **EXCEPT** where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order
  - 2.2. **THE** Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament
  - 2.3. **THE** prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation of any other prohibition or restriction whether made under the Act of 1984 or otherwise

2.4. "civil enforcement officer" has the same meaning as in Section 63A of the Act of 1984 and by virtue of Section 76 of the 2004 Act a civil enforcement officer appointed under Section 63A of the Act of 1984 is a civil enforcement officer in relation to parking contraventions

3. The existing Orders are revoked insofar as they are inconsistent with the proposals contained in the Schedule hereto and insofar as they relate to the length or lengths of the road or roads referred to in the Schedule hereto.

4. Nothing in Article 5 shall relate to a police, fire, ambulance or other emergency vehicle being used in the proper course of its duties

5. Save as provided in Article 4 and except on the direction of a Police Officer in uniform and for access to a building abutting the road, no person shall cause any vehicle to drive on the length or lengths of the road or roads referred to in the Schedule hereto

## **SCHEDULE**

### **PROHIBITION OF DRIVING**

#### **UNNAMED ACCESS ROAD (CLASSIFIED SECTION – PD0112) ADJACENT TO MYNYDD NEWYDD ROAD, RAVENHILL, SWANSEA**

Between points 89 metres and 91 metres north of its junction with the northern kerbline of Pentregethin Road.
