**ORDER 2011**

**THE COUNCIL OF THE CITY AND COUNTY OF SWANSEA** (hereinafter called "the Council") in exercise of its powers under Sections 1 and 84 of the Road Traffic Regulation Act 1984 (as amended) (which said Act of 1984 is hereby referred to as "the Act of 1984") and the Traffic Management Act 2004 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Section 124 of the Act of 1984 hereby make the following Order:

1. **THIS** Order shall come into operation on Friday, the twenty eighth day of January 2011 and may be cited as "the Council of the City and County of Swansea (Revocations) (40 MPH Speed Limit) (Porth Felindre Gateway Northe) Order 2011"
2. **IN** this Order:
  - 2.1. **EXCEPT** where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order
  - 2.2. **THE** Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament
  - 2.3. **THE** prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation of any other prohibition or restriction whether made under the Act of 1984 or otherwise

3. **NOTHING** in Article 5. of this Order shall apply to a vehicle being used for police ambulance fire brigade or other emergency purposes
4. The existing Orders are revoked insofar as they are inconsistent with the provisions contained in the Schedule hereto and insofar as they relate to the length or lengths of the road or roads referred to in the Schedule hereto
5. Except on the direction of a Police Officer in uniform no person shall cause any vehicle to proceed at a speed in excess of 40 miles per hour on the length or lengths of the road or roads referred to in the Schedule hereto

#### **40 MPH SPEED LIMIT**

#### **B4489 PORTH FELINDRE GATEWAY NORTHE**

From the Llangyfelach Roundabout link of junction 46 of the M4 to its junction with the classified section of road - C164 (its entire length, a distance of 1,350 metres)

#### **THE CLASSIFIED SECTION - C164**

From its junction with the B4489 Porth Felindre Gateway Northe to its junction with the unclassified section of road -Y878 (its entire length, a distance of 840 metres)
