THE COUNCIL OF THE CITY AND COUNTY OF SWANSEA (hereinafter called "the Council") in exercise of its powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 (as amended) (which said Act of 1984 is hereby referred to as "the Act of 1984") and the Traffic Management Act 2004 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Section 124 of the Act of 1984 hereby make the following Order.

SECTION 1 - PRELIMINARY

Citation and commencement

 This Order shall come into operation on the 17th day of September 2012 and may be cited as the Council of the City and County of Swansea (Cefn Road, Cefn Hengoed Road, Swansea) traffic regulation order 2012

Definitions

2. In this order, except where the context otherwise requires, the following expressions have the meaning hereby respectively assigned to them:

"bus" shall have the same meaning as in Section 1 of the Public Passenger Vehicles Act 1981;

"civil enforcement officer" has the same meaning as in Section 63A of the Act of 1984 and by virtue of Section 76 of the 2004 Act a civil enforcement

officer appointed under Section 63A of the Act of 1984 is a civil enforcement officer in relation to parking contraventions;

"Council" means the Council of the City and County of Swansea;

"hackney carriage" means a vehicle standing or plying for hire for which a hackney carriage licence has been issued by the Council;

"traffic Warden" means a traffic warden employed by a police authority in pursuance of sections 95 and 96 of the Act of 1984 and any powers or functions given to a traffic warden in this order may also be exercised by a police officer in uniform;

Interpretation

- 3. Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order
- 4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament
- 5. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation of any other prohibition or restriction whether made under the Act of 1984 or otherwise

SECTION 2 – 20MPH ZONE

20 MPH ZONE

6. Save as provided in Articles 7 of this order no person shall, except upon the direction or with the permission of a civil enforcement officer, police community support officer, a police officer in uniform, a traffic warden or a

person authorised by the Council, cause or permit any vehicle to wait proceed along on any of the length or lengths of the road or roads at a speed exceeding 20 MPH referred to in Schedule 1 hereto.

Exemptions

7. Nothing in Clause 6 hereof relates to Police, Fire, Ambulance or any other emergency vehicles.

SECTION 4 – REVOCATION

8. **REVOCATIONS**

The existing Traffic Orders are revoked insofar as they are inconsistent with the proposals hereinafter contained which relate to the length or lengths of road or roads referred to in the schedule hereto.

SCHEDULE

20MPH SPEED LIMIT

CEFN ROAD

From its junction with the eastern kerbline of Mansel Road to a point in line with the eastern curtilage of No.201 Cefn Bryn Road, a distance of 762 metres.

CEFN HENGOED ROAD

From its junction with the north western kerbline of Cefn Road to a point 114 metres north east of the northern most point of the access road to Bonymaen Sports Club, a distance of 282 metres

CALDICOT ROAD

For its entire length

CLYRO COURT

For its entire length

CHEPSTOW PLACE

For its entire length

CALDICOT CLOSE

For its entire length

CHIRK GARDENS

For its entire length

CAERNARVON WAY

For its entire length

CAERPHILLY AVENUE

For its entire length


