ORDER 2012

THE COUNCIL OF THE CITY AND COUNTY OF SWANSEA (hereinafter called "the Council") in exercise of its powers under Sections 1, 2 and 84 of the Road Traffic Regulation Act 1984 (as amended) (which said Act of 1984 is hereby referred to as "the Act of 1984") and the Traffic Management Act 2004 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Section 124 of the Act of 1984 hereby make the following Order:

1. **THIS** Order shall come into operation on 22nd May 2012 and may be cited as "the Council of the City and County of Swansea 30 MPH Speed Limit Clydach Road & Lone Road, Swansea Order 2012"
2. **IN** this Order:
 - 2.1. **EXCEPT** where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order

- 2.2. **THE** Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament
- 2.3. **THE** prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation of any other prohibition or restriction whether made under the Act of 1984 or otherwise
3. Nothing in Article 4 shall apply to a vehicle being used for police, fire, ambulance or other emergency purposes
4. Save as provided in Article 3 and except on the direction of a Police Officer in uniform, no person shall cause any vehicle to proceed at a speed in excess of 30 miles per hour on the length or lengths of the road or roads referred to in the Schedule hereto.

REVOCATIONS

The existing Orders are revoked insofar as they are inconsistent with the proposals hereinafter contained which relate to the length or lengths of the road or roads referred to in the schedules hereto.

CLYDACH ROAD AND LONE ROAD

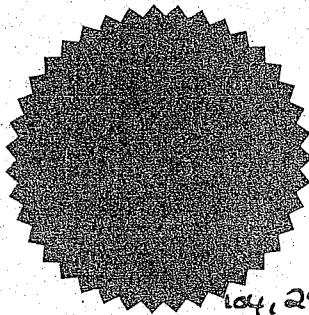
