THE COUNCIL OF THE CITY AND COUNTY OF SWANSEA (hereinafter called "the Council") in exercise of its powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984, as amended (hereinafter referred to as "the Act of 1984") and the Traffic Management Act 2004 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 and Section 124 of the Act of 1984 hereby make the following Order.

SECTION 1 - PRELIMINARY

Citation and commencement

 This Order shall come into operation on the 11th day of January 2013 and may be cited as the Council of the City and County of Swansea A483 Pontardulais Raod, Swansea traffic regulation order 2013

Definitions

In this order, except where the context otherwise requires, the following expressions have the meaning hereby respectively assigned to them:

"civil enforcement officer" has the same meaning as in Section 63A of the Act of 1984 and by virtue of Section 76 of the 2004 Act a civil enforcement officer appointed under Section 63A of the Act of 1984 is a civil enforcement officer in relation to parking contraventions;

Interpretation

- 3. Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order
- 4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament
- The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation of any other prohibition or restriction whether made under the Act of 1984 or otherwise

SECTION 2 – 40MPH SPEED LIMIT

40MPH Speed Limit

6. Save as provided in Articles 7 of this order no person shall, except upon the direction or with the permission of a Civil Enforcement Officer, police officer in uniform, or a person authorised by the Council, cause or permit any vehicle to proceed along the length or lengths of the road or roads referred to in Schedule 1 hereto at a speed in excess of 40 Miles Per Hour (MPH).

Exemptions

7. Nothing in Article 6 of this Order shall apply to any vehicle being used for Police, ambulance, fire brigade or other emergency purposes.

SECTION 3 – REVOCATION

24. The existing Orders are revoked insofar as they are inconsistent with the provisions contained in the Schedules hereto and insofar as they relate to the length or lengths of the road or roads referred to in the Schedules hereto.

SCHEDULE

40 MPH SPEED LIMIT

A483 PONTARDULAIS ROAD

From a point 76 metres south of the southern kerb line of the Pontardulais Road Service Road to a point 259 metres north of the northern kerbline of Pentregethin Road.

PENTREGETHIN ROAD

From its junction with the eastern kerb line of Pontardulais Road for a distance of 75 metres in a easterly direction.

B4620 FFORDD CYNORE

From its junction with the western kerb line of Pontardulais Road for a distance of 22 metres in a westerly direction

PONTARDULAIS ROAD SERVICE ROAD

From its junction with the southern kerbline of Pentregethin Road for a distance 22 metres in a southerly direction

From its junction with the eastern kerbline of Pontardulais Road for a distance of 5 metres in a easterly direction
