**THE COUNCIL OF THE CITY AND COUNTY OF SWANSEA** (hereinafter called "the Council") in exercise of its powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984, as amended (hereinafter referred to as "the Act of 1984") and the Traffic Management Act 2004 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 and Section 124 of the Act of 1984 hereby make the following Order.

**SECTION 1 – PRELIMINARY**

Citation and commencement

1. This Order shall come into operation on Tuesday 8<sup>th</sup> day of April and may be cited as the Council of the City and County of Swansea (Disabled Persons Parking Spaces, Resident Parking and Limited Waiting Permit Holders Exempt) traffic regulation order 2014

Definitions

2. In this order, except where the context otherwise requires, the following expressions have the meaning hereby respectively assigned to them:

"civil enforcement officer" has the same meaning as in Section 63A of the Act of 1984 and by virtue of Section 76 of the 2004 Act a civil enforcement

officer appointed under Section 63A of the Act of 1984 is a civil enforcement officer in relation to parking contraventions;

"public service vehicle" means a vehicle carrying passengers for a fee and for the purposes of this Order public service vehicle refers to a large public service vehicle capable of carrying more than eight passengers;

"relevant position" in respect of:-

- (a) a disabled person's badge and parking disc has the same meaning as in the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (Wales) Regulations 2000; and
- (b) a permit means exhibited on the windscreen, dashboard or fascia of the vehicle or, where the vehicle does not have a windscreen, dashboard or fascia, in a conspicuous position on the vehicle so that the whole of the information on the front of the permit is clearly legible from outside the vehicle;
- (c) a pay and display ticket means exhibited on the windscreen dashboard or fascia of the vehicle or, where the vehicle does not have a windscreen, dashboard or fascia, in a conspicuous position on the vehicle so that the whole of the information on the front of the ticket is clearly legible from outside the vehicle;
- (d) a waiver means exhibited on the windscreen, dashboard or fascia of the vehicle or, where the vehicle does not have a windscreen, dashboard or fascia, in a conspicuous position on the vehicle so that the whole of the information on the front of the waiver is clearly legible from outside the vehicle;

"waiver" means a waiver issued by the Council in respect of vehicles being used for building maintenance repair shop fitting or other industrial or demolition operations and the Council may charge for such

waiver such charge to be determined from time to time by resolution of the Council or relevant Committee thereof

### Interpretation

3. Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order
4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament
5. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation of any other prohibition or restriction whether made under the Act of 1984 or otherwise

## **SECTION 2 – DISABLED BADGE HOLDERS AT ANY TIME**

### Disabled Badge Holders at Any Time

6. No person shall, except upon the direction or with the permission of a civil enforcement officer, police officer in uniform, or a person authorised by the Council, cause or permit any vehicle to wait at any time on the length or lengths of the road or roads referred to in Schedule 1 hereto unless the proper permit has been issued.

## **SECTION 3 – PERMIT HOLDERS OR TWO HOUR LIMITED WAITING NO RETURN WITHIN 4 HOURS, MONDAY TO SATURDAY 8AM TO 6PM**

### Permit Holders or Two Hour Limited Waiting No Return Within 4 Hours, Monday to Saturday 8am to 6pm

7. Save as provided in Articles 8 no person shall, except upon the direction or with the permission of a civil enforcement officer, police officer in uniform, or a person authorised by the Council, cause or permit any vehicle to wait at any time on the length or lengths of the road or roads referred to in Schedule 2 hereto unless the proper permit has been issued.

### Exemptions

8. Nothing in Article 7 of this Order shall render it unlawful to cause or permit any vehicle to wait on the side or sides or length or lengths of the road or roads specified therein for as long as may be necessary to enable:-

- (a) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations namely:-
  - (i) building, maintenance, repair, shop fitting or other industrial or demolition operations with a waiver issued by the Council and displayed in the relevant position on the windscreen of the vehicle;
  - (ii) the removal of any obstruction to traffic;
  - (iii) the laying, erection, alteration or repair in or on land adjacent to the said lengths or sides of the road of any sewer or any main pipe or apparatus for the supply of water, gas electricity or of any telecommunications apparatus as defined by the Telecommunications Act 1984
  - (iv) a vehicle being used for police, ambulance, fire brigade or other emergency purposes
- (b) the vehicle if it cannot conveniently be used for such purpose in any other road, to be used in connection with the service of a local authority or of a water authority in pursuance of its statutory powers and duties.
- (c) the vehicle of the Royal Mail or other universal services provider as defined in Section 4 of the Postal Services Act 2000 to be used for the purpose of delivering or collecting mail.

- (d) public service vehicles when waiting at an authorised bus stop to set down or pick up passengers
- (e) vehicles picking up and dropping off passengers

#### **SECTION 4 – PERMIT HOLDERS ONLY**

##### **Permit Holders**

9. Save as provided in Articles 10 no person shall, except upon the direction or with the permission of a civil enforcement officer, police officer in uniform, or a person authorised by the Council, cause or permit any vehicle to wait at any time on the length or lengths of the road or roads referred to in Schedule 3 hereto unless the proper permit has been issued.

##### **Exemptions**

10. Nothing in Article 9 of this Order shall render it unlawful to cause or permit any vehicle to wait on the side or sides or length or lengths of the road or roads specified therein for as long as may be necessary to enable:-

- (a) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations namely:-
  - (i) building, maintenance, repair, shop fitting or other industrial or demolition operations with a waiver issued by the Council and displayed in the relevant position on the windscreen of the vehicle;
  - (ii) the removal of any obstruction to traffic;
  - (iii) the laying, erection, alteration or repair in or on land adjacent to the said lengths or sides of the road of any sewer or any main pipe or apparatus for the supply of water, gas electricity or of any telecommunications apparatus as defined by the Telecommunications Act 1984
  - (iv) a vehicle being used for police, ambulance, fire brigade or other

emergency purposes

- (b) the vehicle if it cannot conveniently be used for such purpose in any other road, to be used in connection with the service of a local authority or of a water authority in pursuance of its statutory powers and duties.
- (c) the vehicle of the Royal Mail or other universal services provider as defined in Section 4 of the Postal Services Act 2000 to be used for the purpose of delivering or collecting mail.

**SECTION 5 – PERMIT HOLDERS OR ONE HOUR LIMITED WAITING NO  
RETURN WITHIN TWO HOURS, MONDAY TO SATURDAY 8AM TO 6PM**

**Permit Holders**

11. Save as provided in Articles 12 no person shall, except upon the direction or with the permission of a civil enforcement officer, police officer in uniform, or a person authorised by the Council, cause or permit any vehicle to wait at any time on the length or lengths of the road or roads referred to in Schedule 4 hereto unless the proper permit has been issued.

**Exemptions**

12. Nothing in Article 11 of this Order shall render it unlawful to cause or permit any vehicle to wait on the side or sides or length or lengths of the road or roads specified therein for as long as may be necessary to enable:-
  - (a) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations namely:-

- (i) building, maintenance, repair, shop fitting or other industrial or demolition operations with a waiver issued by the Council and displayed in the relevant position on the windscreen of the vehicle;
  - (ii) the removal of any obstruction to traffic;
  - (iii) the laying, erection, alteration or repair in or on land adjacent to the said lengths or sides of the road of any sewer or any main pipe or apparatus for the supply of water, gas electricity or of any telecommunications apparatus as defined by the Telecommunications Act 1984
  - (iv) a vehicle being used for police, ambulance, fire brigade or other emergency purposes
- (b) the vehicle if it cannot conveniently be used for such purpose in any other road, to be used in connection with the service of a local authority or of a water authority in pursuance of its statutory powers and duties.

## **SECTION 6 – PROHIBITION OF WAITING AT ANY TIME**

### Prohibition of Waiting at Any Time

13. Save as provided in Articles 14 no person shall, except upon the direction or with the permission of a civil enforcement officer, police officer in uniform, or a person authorised by the Council, cause or permit any vehicle to wait at any time on the length or lengths of the road or roads referred to in Schedule 5



## Exemptions

14. Nothing in Article 13 of this Order shall render it unlawful to cause or permit any vehicle to wait on the side or sides or length or lengths of the road or roads specified therein for as long as may be necessary to enable:-

- (a) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations namely:-
  - (i) building, maintenance, repair, shop fitting or other industrial or demolition operations with a waiver issued by the Council and displayed in the relevant position on the windscreen of the vehicle;
  - (ii) the removal of any obstruction to traffic;
  - (iii) the laying, erection, alteration or repair in or on land adjacent to the said lengths or sides of the road of any sewer or any main pipe or apparatus for the supply of water, gas electricity or of any telecommunications apparatus as defined by the Telecommunications Act 1984
  - (iv) a vehicle being used for police, ambulance, fire brigade or other emergency purposes
- (b) the vehicle if it cannot conveniently be used for such purpose in any other road, to be used in connection with the service of a local authority or of a water authority in pursuance of its statutory powers and duties.

**SECTION 7 – LIMITED WAITING 10 MINUTES AND DISABLED BADGE  
HOLDERS 10 MINUTES NO RETURN WITHIN 30 MINUTES**

Limited Waiting 10 Minutes and Disabled Badge Holders 10 Minutes No Return  
within 30 Minutes

15. Save as provided in Articles 16 no person shall, except upon the direction or with the permission of a civil enforcement officer, police officer in uniform, or a person authorised by the Council, cause or permit any vehicle to wait at any time on the length or lengths of the road or roads referred to in Schedule 6 hereto unless the proper permit has been issued.

Exemptions

16. Nothing in Article 15 of this Order shall render it unlawful to cause or permit any vehicle to wait on the side or sides or length or lengths of the road or roads specified therein for as long as may be necessary to enable:-

- (a) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations namely:-
- (i) building, maintenance, repair, shop fitting or other industrial or demolition operations with a waiver issued by the Council and displayed in the relevant position on the windscreen of the vehicle;
  - (ii) the removal of any obstruction to traffic;
  - (iii) the laying, erection, alteration or repair in or on land adjacent to the said lengths or sides of the road of any sewer or any main pipe or apparatus for the supply of water, gas electricity or of any telecommunications apparatus as defined by the Telecommunications Act 1984
  - (iv) a vehicle being used for police, ambulance, fire brigade or other emergency purposes
- (b) the vehicle if it cannot conveniently be used for such purpose in any other

road, to be used in connection with the service of a local authority or of a water authority in pursuance of its statutory powers and duties.

- (c) the vehicle of the Royal Mail or other universal services provider as defined in Section 4 of the Postal Services Act 2000 to be used for the purpose of delivering or collecting mail.
- (d) public service vehicles when waiting at an authorised bus stop to set down or pick up passengers
- (i) vehicles picking up and dropping off passengers

## **SECTION 8 – DISABLED BADGE HOLDERS ONLY 3 HOURS NO RETURN WITHIN 3 HOURS**

### Limited Waiting 10 Minutes and Disabled Badge Holders 10 Minutes No Return within 30 Minutes

17. Save as provided in Articles 18 no person shall, except upon the direction or with the permission of a civil enforcement officer, police officer in uniform, or a person authorised by the Council, cause or permit any vehicle to wait at any time on the length or lengths of the road or roads referred to in Schedule 7 hereto unless the proper permit has been issued.

### Exemptions

18. Nothing in Article 17 of this Order shall render it unlawful to cause or permit any vehicle to wait on the side or sides or length or lengths of the road or roads specified therein for as long as may be necessary to enable:-
- (a) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations namely:-
    - (ii) building, maintenance, repair, shop fitting or other industrial or

- demolition operations with a waiver issued by the Council and displayed in the relevant position on the windscreen of the vehicle;
- (ii) the removal of any obstruction to traffic;
  - (iii) the laying, erection, alteration or repair in or on land adjacent to the said lengths or sides of the road of any sewer or any main pipe or apparatus for the supply of water, gas electricity or of any telecommunications apparatus as defined by the Telecommunications Act 1984
  - (iv) a vehicle being used for police, ambulance, fire brigade or other emergency purposes
- (b) the vehicle if it cannot conveniently be used for such purpose in any other road, to be used in connection with the service of a local authority or of a water authority in pursuance of its statutory powers and duties.
- (c) the vehicle of the Royal Mail or other universal services provider as defined in Section 4 of the Postal Services Act 2000 to be used for the purpose of delivering or collecting mail.
- (d) public service vehicles when waiting at an authorised bus stop to set down or pick up passengers
- (j) vehicles picking up and dropping off passengers

## **SECTION 9 – LIMITED WAITING ONE HOUR NO RETURN WITHIN TWO HOURS**

### Limited Waiting 10 Minutes and Disabled Badge Holders 10 Minutes No Return within 30 Minutes

19. Save as provided in Articles 20 no person shall, except upon the direction or with the permission of a civil enforcement officer, police officer in uniform, or a person authorised by the Council, cause or permit any vehicle to wait at any time on the length or lengths of the road or roads referred to in Schedule 8 hereto unless the proper permit has been issued.

## Exemptions

20. Nothing in Article 19 of this Order shall render it unlawful to cause or permit any vehicle to wait on the side or sides or length or lengths of the road or roads specified therein for as long as may be necessary to enable:-
- (a) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations namely:-
    - (iii) building, maintenance, repair, shop fitting or other industrial or demolition operations with a waiver issued by the Council and displayed in the relevant position on the windscreen of the vehicle;
    - (ii) the removal of any obstruction to traffic;
    - (iii) the laying, erection, alteration or repair in or on land adjacent to the said lengths or sides of the road of any sewer or any main pipe or apparatus for the supply of water, gas electricity or of any telecommunications apparatus as defined by the Telecommunications Act 1984
    - (iv) a vehicle being used for police, ambulance, fire brigade or other emergency purposes
  - (b) the vehicle if it cannot conveniently be used for such purpose in any other road, to be used in connection with the service of a local authority or of a water authority in pursuance of its statutory powers and duties.
  - (c) the vehicle of the Royal Mail or other universal services provider as defined in Section 4 of the Postal Services Act 2000 to be used for the purpose of delivering or collecting mail.
  - (d) public service vehicles when waiting at an authorised bus stop to set down or pick up passengers
  - (k) vehicles picking up and dropping off passengers

## **REVOCATION**

21. The existing Orders are revoked insofar as they are inconsistent with the proposals contained in the schedules hereto and insofar as they relate to the length or lengths of the road or roads referred to in the Schedule hereto.

### **DOCTOR PERMIT HOLDERS ONLY**

#### **DAN Y GRAIG ROAD - South Side**

From a point 26 metres north-east of the north-eastern kerb line of Port Tennant Road for a distance of 12 metres in a north-easterly direction.

### **PROHIBITION OF WAITING AT ANY TIME**

#### **NORTON ROAD - South Side**

From a point 55 metres west of its junction with the western kerb line of Castle Acre to a point 8 metres west of that point.

From a point 12 metres east of its junction with the south eastern kerb line of Kinley Street to a point 7 metres west of that point.

**South side**

From a point 50 metres west of a point opposite the western kerb line of Monton Terrace to a point 7 metres west of that point.

**ST ELMO AVENUE - West side**

From a point 72 metres north west of its junction with the western kerb line of Beaumont Crescent to a point 7 metres north of that point.

**SCHEDULE 2 - PERMIT HOLDERS OR TWO HOUR LIMITED WAITING NO

From a point 5 metres east of its junction with the eastern kerb line of Jersey Terrace to a point 20 metres east of that point.

From a point 19 metres east of its junction with the eastern kerb line of Tymawr Street to a point 26 metres east of that point.

#### **North Side**

From a point 47 metres east of its junction with the eastern kerb line of the access road to St Thomas cemetery to a point 37 metres east of that point.

From a point 110 metres east of its junction with the eastern kerb line of the access road to St Thomas cemetery to a point 41 metres east of that point.

From a point 194 metres east of its junction with the eastern kerb line of the access road to St Thomas cemetery to a point 40 metres east of that point.

#### **HILL STREET - West side**

From a point 26 metres south of its junction with the southern kerb line of North Hill Road to a point 30 metres south of that point.

From a point 95 metres south of its junction with the southern kerb line of North Hill Road to a point 35 metres south of that point.

#### **MIDDLETON STREET**

##### **West Side**

From a point 5 metres north of its junction with the northern kerb line of Port Tennant Road to a point 13 metres north of that point.

From a point 28 metres north of its junction with the northern kerb line of Port Tennant Road to a point 56 metres north of that point.

From a point 89 metres north of its junction with the northern kerb line of Port Tennant Road to a point 45 metres north of that point.

##### **East Side**

From a point 5 metres north of its junction with the northern kerb line of Port Tennant Road to a point 15 metres north of that point.

From a point 30 metres north of its junction with the northern kerb line of Port Tennant Road to a point 104 metres north of that point.

#### **TOWNHILL ROAD - North side**

From a point 42 metres east of its junction with the eastern kerb line of Tower Gardens to a point 25 metres east of that point.

### **UPTON TERRACE - North Side**

From a point 43 metres east of its junction with the south eastern kerb line of Kinley Street to a point 60 metres east of that point.

### **WATKIN STREET - West side**

From a point 5 metres south of its junction with the southern kerb line of Short Street to a point 18 metres south of that point

#### **South East Side**

From a point 68 metres north west of its junction with the north western kerb line of Morris lane to a point 38 metres north west of that point.

### **MARGARET STREET**

#### **Western side**

From a point 6 metres south of its junction with the south side of Upton Terrace to a point 43 metres south of that point.

From a point 74 metres south of its junction with the south side of Upton Terrace to a point 30 metres south of that point.

**Eastern side**

From a point 25 metres south of its junction with the south east kerb line of Longford Crescent to a point 68 metres south of that point.

**MUMBLES ROAD (LAY BY) BLACKPILL - West side**

From a point 68 metres south of its junction with the southern kerb line of Mill Lane to a point 34 metres south of that point

**MUMBLES ROAD SOUTHEND - South side**

From its junction with the eastern side of the car park fronting the George Public House to point 20 metres east of that point.

From a point 68 metres east of its junction with the eastern side of the car park fronting the George Public House to point 12 metres east of that point.

From its junction with the western side of Dickslade to a point 24 metres west of that junction.

From a point 72 metres west of its junction with the western side of Dickslade to a point 10 metres west of that point.

From a point 99 metres west of its junction with the western side of Dickslade to a point 17 metres west of that point.

**PENIEL GREEN ROAD - North east side**

From a point 120 metres south east of its junction with the south east kerb line of the B4291 to a point 20 metres south east of that point.

**PENLAN CRESCENT - North side**

From a point 213 metres east of its junction with the eastern kerb line of Notts Gardens to a point 7 metres east of that point. Note parking is in echelon fashion.

**ST MICHAEL'S AVENUE PONTARDDULAIS - East side**

From a point 10 metres south of its junction with the southern kerb line of Water Street to a point 25 metres south of that point.

### **TERRACE ROAD - South Side**

From a point 110 metres west of its junction with the western kerb line of Harcourt Street to a point 22 metres west of that point.

### **VIVIAN ROAD - East Side**

From a point 50 metres south of its junction with the southern kerb line of Tycoch Road to a point 28 metres south of that point.

From a point 108 metres south of its junction with the southern kerb line of Tycoch Road to a point 28 metres south of that point.

From a point 169 metres south of its junction with the southern kerb line of Tycoch Road to a point 34 metres south of that point.

### **WESTBOURNE GROVE**

#### **West Side**

From a point 42 metres south of its junction with the southern kerb line of Westbourne Road to a point 32 metres south of that point

#### **East Side**

From a point 5 metres south of its junction with the southern kerb line of Westbourne Road to a point 37 metres south of that point.

### **WHITE STREET - West side**

From a point 29 metres south of its junction with the southern kerb line of Hanover Street to a point 25 metres south of that point.

### **WINDMILL TERRACE - North east side**
