SCHEDULE 2 **PROHIBITION OF WAITING AT ANY TIME** **VICTORIA ROAD B4296**

West side

From its junction with the southern kerblineline of Loughor Road to a point 68 metres south thereof

From a point 80 metres south of the southern kerblineline of Loughor Road to its junction with the northern kerblineline of the A484

East side

From its junction with the southern kerblineline of Swansea Road to a point 112 metres south thereof

From a point 124 metres south of the southern kerblineline of Swansea Road to its junction with the northern kerblineline of the A484
